

APPLICATION

UNION OIL COMPANY OF CALIFORNIA d/b/a UNOCAL, through its undersigned attorneys, hereby applies to the New Mexico Oil Conservation Division for an Order terminating prorationing in the South Blanco-Pictured Cliffs Gas Pool, Rio Arriba, Sandoval and San Juan Counties, New Mexico, and in support thereof would show:

1. Applicant is an operator and working interest owner in the South Blanco-Pictured Cliffs Gas Pool ("the Pool").
2. The Pool was established by Division Order No. R-156 and made effective May 20, 1952. The current Pool is described on Exhibit A to this application which is incorporated herein.
3. Prorationing has been instituted in the Pool by the Division and is subject to the provisions of Order R-8170, as amended, the General Rules and Regulations for the Prorated Gas Pools of New Mexico.
4. Prorationing was originally instituted because the total delivery capacity of the wells in the Pool exceeded the market demand for gas produced from the Pool.

5. Productivity from the Pool had declined with wells in the Pool currently producing at an average rate of less than 30 mcf per day and with over 95% of the wells producing less than 100 mcf per day.

6. Currently and for the remaining life of the Pool, the total deliverability of the wells in the Pool is not expected to exceed market demand for gas produced from the Pool.

7. The production limitations imposed by the prorated allowables are unnecessary and have caused and will continue to discourage further development drilling, attempted workovers of existing wells, or the installation of compression equipment.

8. Termination of prorationing for the Pool will not result in waste nor impair correlative rights.

9. In addition to the decline in Pool production, changes in gas purchasing and marketing practices, and other factors affecting the oil and gas industry make prorationing of the Pool unnecessary.

10. Applicant proposes that prorationing for the Pool be terminated effective September 1, 1992.

11. Applicant has contacted the operators in the Pool concerning this matter and is not aware of any opposition to this Application.


12. Applicant requests that this matter be set for hearing on the Examiner's docket now scheduled for August 6, 1992.

13. Notice of this application has been provided in accordance with Division rules.

WHEREFORE, Union Oil Company of California d/b/a Unocal requests that this application be set for hearing before a duly appointed Examiner of the Oil Conservation Division and, after notice and hearing as required by law and the rules of the Division, the Division enter its order terminating prorationing for the South Blanco-Pictured Cliffs Gas Pool.
