## STATEMENT OF CASE

### PARTICIPANT

Southland Royalty Company seeks approval to deepen its South Corbin Federal Well No 3, located 554 feet in the South and East lines (Unit P) of Section 20, Township 18 South, Range 33 East, from the South Corbin-Wolfcamp Pool to test the Undesignated South Corbin-Morrow Gas Pool. Said location is considered unorthodox pursuant to General Rule 104.C.(2). Further, the E/2 of said Seciton 20 is to be dedicated to said well forming a standard 320-acre gas spacing and proration unit in the Morrow interval.
