#### **APPLICATION**

AMERICAN HUNTER EXPLORATION, LTD., ("American Hunter") through its undersigned attorneys, hereby makes application to the Oil Conservation Division for approval of an unorthodox well location and in support of its application states:

- Applicant is the operator of the NE/4 NE/4 of Section 2, Township 27 North, Range 2 West, N.M.P.M., Rio Arriba County, New Mexico, and proposes to drill its Jicarilla 2A Well No. 1 at an unorthodox location 1000 feet from the North line and 1300 feet from the East line of said Section 2.
- 2. Applicant seeks an exception to the well location requirements of Division Rule 104 to permit the drilling of the well at the above-described unorthodox location to a depth to adequately test the Mancos formation.
