THE APPLICATION OF THE OIL CONSERVATION DIVISION UPON ITS OWN MOTION FOR AN ORDER CREATING AND EXTENDING CERTAIN POOLS IN EDDY AND LEA COUNTIES, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on September 17, 1992, at Santa Fe, New Mexico, before Examiner David R. Catanach.

NOW, on this <u>25th</u> day of September, 1992, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises:

FINDS THAT:

(1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) There is need for the dismissal of the proposed creation of the East Big Dog-Strawn Pool in Lea County, New Mexico, since said pool has already been created by Division Order No. R-9722.

(3) There is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Atoka formation, said pool to bear the designation of East Caprock-Mississippian Gas Pool. Said East Caprock-Mississippian Gas Pool was discovered by the WOG Inc. State Well No. 1 located in Unit A of Section 11, Township 11 South, Range 32 East, NMPM. It was completed in the Atoka formation on April 29, 1992. The top of the perforations is at 10,558 feet.

(4) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Grayburg formation, said pool to bear the designation of Lone Ranger-Grayburg Pool. Said Lone Ranger-Grayburg Pool was discovered by the Pogo Producing Company Buffalo Federal Well No. 1 located in Unit B of Section 11, Township 19 South, CASE NO. 10561 Order No. R-9723 -2-

Range 33 East, NMPM. It was completed in the Grayburg formation on July 1, 1992. The top of the perforations is at 4,935 feet.

(5) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of Rattlesnake Flat-Delaware Pool. Said Rattlesnake Flat-Delaware Pool was discovered by the Yates Petroleum Corporation Arapaho AKP Federal Well No. 1 located in Unit O of Section 29, Township 26 South, Range 33 East, NMPM. It was completed in the Delaware formation on April 28, 1992. The top of the perforations is at 4,820 feet.

(6) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of West Triste Draw-Delaware Pool. Said West Triste Draw-Delaware Pool was discovered by the Harvard Petroleum Corporation State IG Well No. 1 located in Unit B of Section 32, Township 23 South, Range 32 East, NMPM. It was completed in the Delaware formation on April 8, 1992. The top of the perforations is at 7,992 feet.

(7) There is need for certain extensions of the North Airstrip-Bone Spring Pool, the North Anderson Ranch-Wolfcamp Pool, the ARAB-C-San Andres Pool, the Bilbrey-Morrow Gas Pool, the Buffalo-Queen Pool, the Buffalo-Yates Pool, the Corbin-Bone Spring Pool, the South Corbin-Wolfcamp Pool, the East Livingston Ridge-Delaware Pool, the East Lusk-Wolfcamp Pool, the Querecho Plains-Delaware Pool, the Red Hills-Wolfcamp Gas Pool, the Rhodes Yates-Seven Rivers Gas Pool, the Teague-Blinebry Pool, the Teas-Bone Spring Pool, the Tonto-Bone Spring Pool, and the North Tulk-Wolfcamp Pool, all in Lea County, New Mexico, and the Lost Tank-Delaware Pool in Eddy and Lea Counties, New Mexico.

IT IS THEREFORE ORDERED THAT:

(a) The creation of a new pool in Lea County, New Mexico, classified as an oil pool for Strawn production to be designated as the East Big Dog-Strawn Pool, is hereby <u>dismissed</u>.

(b) A new pool in Lea County, New Mexico, classified as a gas pool for Atoka production is hereby created and designated as the East Caprock-Mississippian Gas Pool, consisting of the following described area:

IT IS FURTHER ORDERED THAT:

(1) Pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.

(2) The effective date of this order and all creations and extensions included herein shall be October 1, 1992.
