NOW, on this 23rd day of November, 1992, the Division Director, having considered the record and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

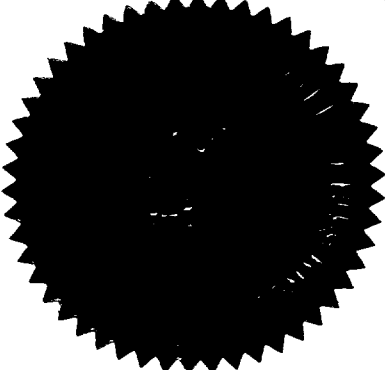
- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) The applicant, SG Interests I, Ltd., seeks an order pooling all mineral interests in the Basin-Fruitland Coal Gas Pool underlying the E/2 of Section 18, Township 30 North, Range 9 West, NMPM, San Juan County, New Mexico, forming a standard 320-acre gas spacing and proration unit for said pool. Said unit is to be dedicated to a well to be drilled at a standard coal gas well location in the NE/4 of said Section 18.

- (3) By letter dated November 6, 1992, the applicant requested this case be dismissed.
- (4) The applicant's request for dismissal should be granted.


IT IS THEREFORE ORDERED THAT:
