- (2) The applicant, SG Interests I, Ltd., seeks an order pooling all mineral interests in the Basin-Fruitland Coal Gas Pool underlying Lots 3 and 4, the SW/4 and N/2 SE/4 (S/2 equivalent) of Section 25, Township 30 North, Range 9 West, NMPM, San Juan County, New Mexico, forming a standard 331.38-acre gas spacing and proration unit for said pool. Said unit is to be dedicated to a well to be drilled at a standard coal gas well location in the SW/4 of said Section 25.
 - (3) By letter dated November 6, 1992, the applicant requested this case be dismissed.
 - (4) The applicant's request for dismissal should be granted.
