



This letter is to advise you that Amoco Production Company has filed the enclosed application with the New Mexico Oil Conservation Division seeking approval of an unorthodox gas well location in the Basin-Fruitland Coal Gas Pool for its proposed Fields A-21-R Well to be located 820 feet from the North line and 1820 feet from the West line of Section 25, Township 32 North, Range 11 West, N.M.P.M., San Juan County, New Mexico. Amoco also seeks to rededicate acreage in Section 25 to create two stand up 320-acre spacing units in the Basin-Fruitland Coal Gas Pool.


