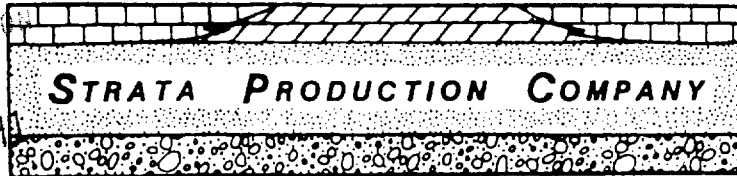

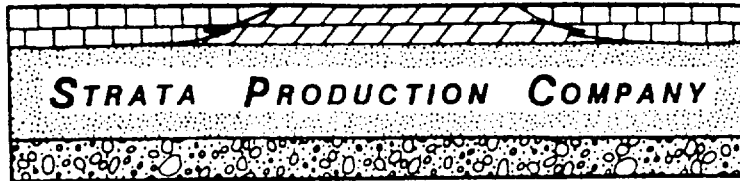



OXY USA Inc. objects to administrative approval of the subject application. We are concerned about the effect of water disposal into the requested zone because we operate several Wolfcamp and Morrow wells immediately north of the proposed disposal well. Our wells do not appear to be cemented across the proposed injection zone, hence our concerns.

Our copy of the application was mailed to "Cities Service Oil and Gas Corp., Tulsa, Oklahoma", an entity that doesn't exist, instead of OXY USA Inc.'s Midland office. Consequently, we have had very little time to completely review the application. It is possible that after further review and discussions with the applicant, we may withdraw our protest. By copy of this letter we are notifying Strata of our protest and the reasons for it. All future correspondence should be sent to the undersigned at OXY's Midland office.
