Gentlemen:

Santa Fe proposes the formation of a Working Interest Unit covering the captioned land on the following terms:

Acreage Committed: Santa Fe will commit its 2,800 acres, more or less and Yates agrees to commit its 760 acres, more or less and the working interest ownership would be:

SFEOP, L.P., et al	78.65%
Yates	<u>21.35%</u>
	100.00%

Initial Test Well: On or before July 1, 1992 Santa Fe, as operator shall commence a 10,205' Morrow Test in the NW/4 of Section 34, T-21-S, R-24-E. Yates agrees to participate with its 21.35% working interest under the terms of a mutually acceptable Unit Operating Agreement.

Title: Both parties agree that this proposal is subject to a 15 day title review of the captioned acreage.

Santa Fe will provide Yates a geological review upon Yates election to participate as a working interest owner as set out above or to farmout its acreage to the Working Interest Unit delivering a 75% net revenue interest with the option to cover the retained overriding royalty interest to a 25% working interest with a one time election to participate with its back-in interest on subsequent wells or retain its overriding royalty interest.

In reference to our telephone conversation concerning the captioned prospect, Santa Fe Energy Operating Partners, L.P., (Santa Fe) respectfully requests a farmout of your acreage in the S/2 of Section 27, T-21-S, R-24-E, Eddy County, New Mexico, less and except the SW/4 SW/4 of Section 27, under the following general terms:

1. On or before 180 days from the date of a formal agreement Santa Fe will commence the drilling of an initial test well to be at a location of its choice in the S/2 of Section 27, and drill to a depth of 9,850' or sufficient to test the Morrow Formation.
2. Upon completion of a well capable of commercial production, Yates will assign 100% of its operating rights from the surface to 100' below total depth drilled in the spacing unit for the well.
3. Yates will retain an overriding royalty sufficient to deliver Santa Fe a 75% net revenue interest. At payout of the initial test well Yates shall have the option to convert the retained overriding royalty interest to a 25% working interest.
4. Santa Fe shall have the right to drill subsequent wells on the farmout acreage by commencing a subsequent well within 120 days from completion of one well and spud of a subsequent well.

5. Yates shall have a one time election on subsequent wells to either retain the overriding royalty interest or participate with its 25% back-in interest.
