APPLICATION

Comes now CONOCO INC., by and through its attorneys, KELLAHIN and KELLAHIN, and applies to the New Mexico Oil Conservation Division for approval of an unorthodox oil well location for its Barbara Federal #16 Well in the North Dagger Draw-Upper Pennsylvanian Oil Pool, Eddy County, New Mexico to be drilled at an unorthodox location 1980 feet FNL and 1530 feet FWL (Unit F) Section 18, Township 19 South, Range 25 East, NMPM, Eddy County, New Mexico and to be dedicated to a 160-acre standard oil proration and spacing unit consisting of the NW/4 of said Section 18.

In support thereof, Applicant states:

1. Applicant, Conoco Inc., has the right to drill and test for production in the NW/4 of Section 18, T19S, R25E, N.M.P.M, Eddy County, New Mexico.

- 2. Applicant proposes to test for production by locating the subject well as described above.
- 3. The proposed well will be located within the current boundaries of the North Dagger Draw-Upper Pennsylvanian Oil Pool.
- 4. The subject pool was created by Order R-4691 dated December 11, 1973 and was initially spaced on 320 acre spacing (Rule 2) with Rule 4 setting standard well locations to be not closer than 660 feet to any outer boundary of the spacing unit, nor closer than 330 feet to any quarter-quarter section line.
- 5. Thereafter, on February 3, 1976, the Division entered Order R-4691-A which amended Rule 2 changing the spacing from 320 acres to 160 acres, but did not amend Rule 4 as to well locations.
- 6. The proposed well would be at unorthodox location because it is 210 feet from the east side of SE/4NW/4 rather than the required 330 feet and would require an exception to Rule 4 of the subject pool.
- 7. The standard locations within this spacing unit are either too close to the Barbara Federal #5 Well, a plugged and abandoned well in this pool, which is located

1980 feet from north and west lines of Section 18, or are too close to the edge of the productive limits of the pool.

- 8. A well at the proposed unorthodox location should penetrate productive intervals of the Canyon formation at more favorable geologic points than a well drilled at standard locations in the proposed spacing unit and/or should be outside of the drainage affects of the Barbara Federal #5 Well thereby increasing the likelihood of obtaining commercial production.
- 9. Approval of the application will afford the applicant the opportunity to produce its just and equitable share of the oil in the Canyon formation, will prevent the economic loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells and will otherwise prevent waste and protect correlative rights.
