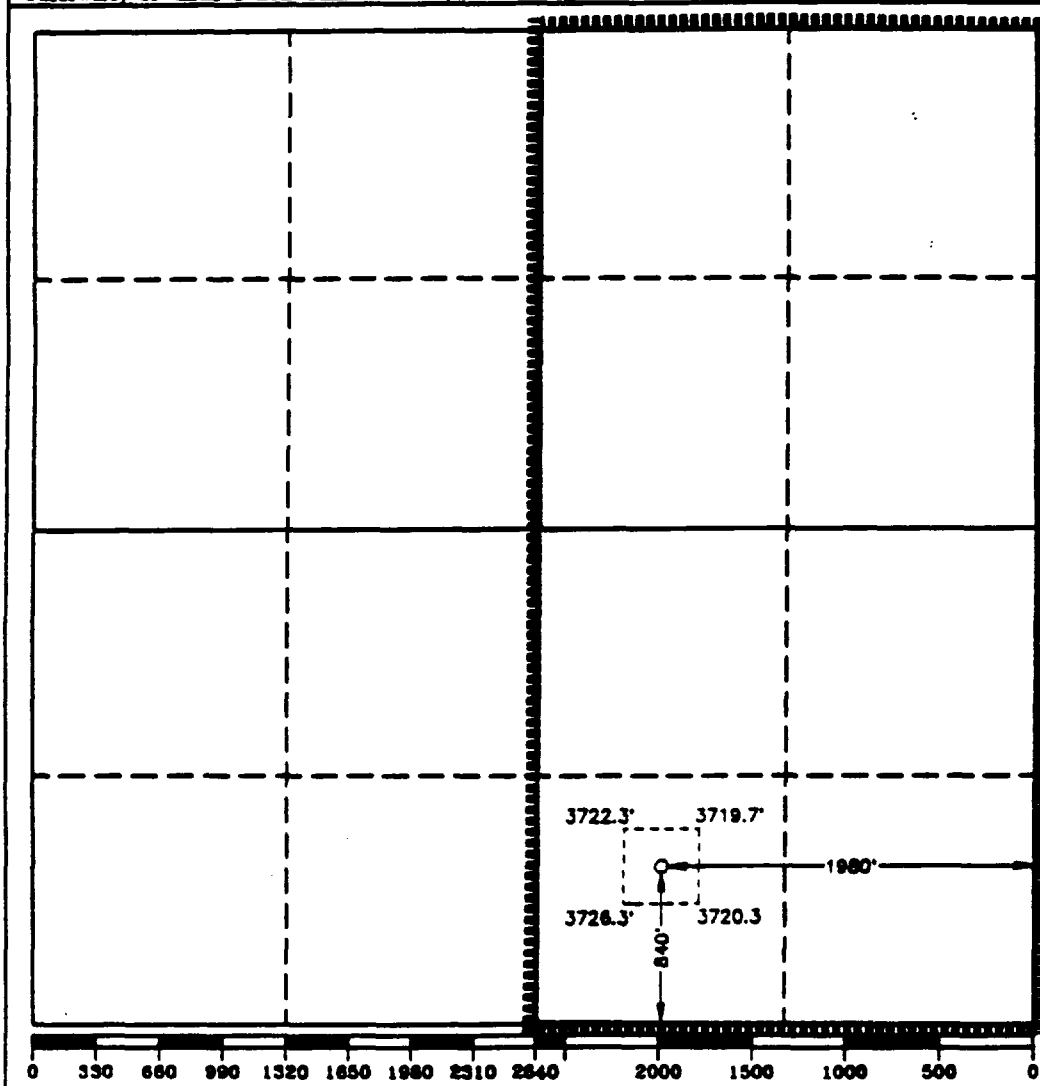



Dear Ms. Porter:

Conoco, Inc. has applied for the above referenced unorthodox Morrow location which is offset to the west by Yates' acreage in section 34, and to the south by Yates/Conoco acreage in the nonstandard section 35. The unorthodox location is for the Morrow Formation (Cisco is orthodox), and is required due to surface topographic problems and geological considerations.

As discussed and agreed to in our phone conversation on March 1, in exchange for Yates waiving all objection to this application, Conoco agrees to waive all objection to a similar unorthodox bottom hole location (i.e., no closer than 840' FSL and no further than 1980' FWL), should Yates wish to drill an unorthodox Morrow location in the west half of section 34, T-20S, R-24E.
