

COMES NOW YATES PETROLEUM CORPORATION, through its undersigned attorneys, and hereby makes application for an order approving an unorthodox well location, and in support thereof states:

- 1. Applicant is the operator of the E/2 of Section 26, Township 20 South, Range 24 East, N.M.P.M., Eddy County, New Mexico and proposes to recomplete its Conoco AGK Federal Well No. 9 as a gas well in the Morrow formation, Cemetary Morrow Gas Pool, 660 feet from the South line and 860 feet from the East line in Unit P of said Section 26. This well was originally drilled to the Canyon formation.
- 2. Applicant seeks an exception to the Division's well location requirements to permit the recompletion of the well in the Morrow formation at the above-described location.
- 3. A standard 320-acre proration unit comprised of the E/2 of said Section 26 should be dedicated to the well.
- 4. Approval of this application will afford Applicant the opportunity to produce its just and equitable share of the gas in the Morrow formation and will otherwise be in the best interest of the conservation, the protection of correlative rights and prevention of waste.

WHEREFORE, Applicant requests that this matter be set for hearing before a duly appointed Examiner of the Oil Conservation Division on April 8, 1993, that notice be given as required by law and the rules of the Division, and that the Division enter its order granting this application and providing such other relief as is proper.
