Dear Mr. LeMay:

On May 18, 1993, the Division entered Order No. R-9896 in the above-referenced case granting the application of Yates Petroleum Corporation to institute a waterflood project in its Creek "AL" Federal Lease. Order Paragraph 15 provides that the injection authority granted by this Order will terminate one year after the effective date of Order No. R-9896 (May 18, 1994), if injection operations have not been commenced by that time unless the Division has granted an extension of this Order for good cause shown upon written request of the operator. On April 14 of this year, Yates requested and received an extension of this Order through November 15, 1994.

Yates Petroleum Corporation plans to implement this waterflood project and is cooperating with Hanson Operating Company, Inc. to implement Hanson's adjoining Benson Shugart Waterflood Unit Project. While recent oil prices made it imprudent to implement waterflood operations on the Creek "AL" Federal Lease, Yates has decided to go forward with this project during the next six months. Accordingly, pursuant to the provisions of Order Paragraph No. 15 of Order No. R-9896, Yates Petroleum Corporation hereby requests an extension of the time within which to commence injection operations pursuant to this Order through May 15, 1995.
