Comes now Meridian Oil Inc., by and through its attorneys, Kellahin, Kellahin & Aubrey, and applies to the New Mexico Oil Conservation Division to **reopen** Case 10486 and to amend Division Order R-9702 in order to change the commencement point of its previously approved Black Diamond Com "20" Well No. 1 to commence at an unorthodox surface location 120 feet FNL and 120 feet FWL of Section 20, Township 30 North, Range 15 West, being a previously approved High Angle/Horizontal Direction Drilling Pilot Project located in the W/2 of

said Section 20, Undesignated Horseshoe-Gallup Oil
Pool. Said pilot project area is located approximately
4.75 miles northwest by north of Fruitland, New Mexico.

In support thereof Meridian Oil Inc. states:

(1) Applicant is an operator in Section 20, T30N,R15W, N.M.P.M., San Juan County, New Mexico.

(2) On August 6, 1992, The Division entered Order R-9702 which, among other things, approved applicant's High Angle/ Horizontal Directional Drilling Pilot Project for Section 20, T30N, R15W and authorized applicant to commence its proposed Black Diamond "20" Well No. 1 at an unorthodox surface location in the SE/4SW/4 of Section 20 estimated to be 195 feet FSL and 2510 feet FWL of said Section 20.

(3) Applicant has re-evaluated its well prognosis and now seeks to place the surface location for the Black Diamond "20" Well No 1 in the NW/4NW/4 commencing at a point 120 feet FNL and 120 feet FWL of said Section 20, with a projected bottom hole location no

(4) The proposed amendments to Order R-9702 will allow the applicant to drill the subject well vertically to a depth of approximately 4250 feet and then come up hole to a point at approximately 3579 feet where applicant will kick off the well in an southeasterly direction (approximately azimuth of 155 degrees) and commence to build an angle of 12 degrees per 100 feet to approximately 80 degrees and penetrate the top of the "Waterflow" zone of the Niobrara member of the Horseshoe Gallup Oil Pool at an estimated total vertical depth of 4085 feet, and then to continue to build angle to 90 degrees and thence drilling horizontally in a lateral distance not in excess of 4689 feet and no closer than 330 feet to the outer boundaries of the 320-acre spacing and proration unit. (5) Applicant proposes that Decretory Paragraphs
(1) and (2) of Division Order R-9702 be deleted and new
Decretory Paragraphs (1) and (2) be adopted as follows"

"(1) The applicant, Meridian Oil Inc. is hereby authorized to initiate a high angle/horizontal directional drilling pilot project in the W/2 of Section 20, T30N, R15W, NMPM, Undesignated Horseshoe-Gallup Oil Pool, San Juan County, New Mexico, by drilling its Black Diamond "20" Well No.1 from an unorthodox surface location 120 feet from the North and West lines (Unit D) of Section 20, in the following unconventional manner:

Drill vertically to a depth of approximately 4250 feet and then come up hole to a point at approximately 3579 feet and kick off the well in an southeasterly direction (approximately azimuth of 155 degrees) and commence to build an angle of 12 degrees per 100 feet to approximately 80 degrees and penetrate the top of the Waterflow" zone of the Niobrara member of Horseshoe Gallup Oil Pool at an estimated total vertical depth of 4085 feet, and then to continue to build angle to 90 degrees and thence drilling horizontally in a lateral

distance not in excess of 4689 feet and no closer than 330 feet to the outer boundary of the designated project area.

**PROVIDED HOWEVER THAT**, no portion of the horizontal portion of the wellbore shall be located closer than 330 feet from the outer boundary of the project area."

(2) The applicant shall dedicate the W/2 of Section 20 to the above described well forming a nonstandard 320 acre oil spacing and proration unit which is also hereby approved."

(6) The Waterflow interval of the Gallup is believed to be the potential productive zone at this location in the Horseshoe Gallup Oil Pool. This interval produces through intergranular permeability.

(7) Past experience in said pool has shown that unless a conventionally drilled (vertical) well intersects natural fractures, the chance of obtaining commercial production is severely curtailed.

(10) As required, notice is provided to those offsetting operators as listed on Exhibit "D."

(11) The granting of this Application will be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Applicant requests that this matter be set for hearing on April 22, 1993 before a duly appointed Examiner of the Oil Conservation Division and, after notice and hearing as required by law, the Division enter its Order granting this application.

### <u>APPLICATION</u>

Comes now Meridian Oil Inc., by and through its attorneys, Kellahin, Kellahin & Aubrey, and applies to the New Mexico Oil Conservation Division to **reopen** Case 10486 and to amend Division Order R-9702 in order to change the commencement point of its previously approved Black Diamond Com "20" Well No. 1 to commence at an unorthodox surface location 120 feet FNL and 120 feet FWL of Section 20, Township 30 North, Range 15 West, being a previously approved High Angle/Horizontal Direction Drilling Pilot Project located in the W/2 of

said Section 20, Undesignated Horseshoe-Gallup Oil
Pool. Said pilot project area is located approximately
4.75 miles northwest by north of Fruitland, New Mexico.

In support thereof Meridian Oil Inc. states:

(1) Applicant is an operator in Section 20, T30N,R15W, N.M.P.M., San Juan County, New Mexico.

(2) On August 6, 1992, The Division entered Order R-9702 which, among other things, approved applicant's High Angle/ Horizontal Directional Drilling Pilot Project for Section 20, T30N, R15W and authorized applicant to commence its proposed Black Diamond "20" Well No. 1 at an unorthodox surface location in the SE/4SW/4 of Section 20 estimated to be 195 feet FSL and 2510 feet FWL of said Section 20.

(3) Applicant has re-evaluated its well prognosis and now seeks to place the surface location for the Black Diamond "20" Well No 1 in the NW/4NW/4 commencing at a point 120 feet FNL and 120 feet FWL of said Section 20, with a projected bottom hole location no

closer than 330 feet from the outer boundary of a spacing unit consisting of the W/2 of said Section 20.

(4) The proposed amendments to Order R-9702 will allow the applicant to drill the subject well vertically to a depth of approximately 4250 feet and then come up hole to a point at approximately 3579 feet where applicant will kick off the well in an southeasterly direction (approximately azimuth of 155 degrees) and commence to build an angle of 12 degrees per 100 feet to approximately 80 degrees and penetrate the top of the "Waterflow" zone of the Niobrara member of the Horseshoe Gallup Oil Pool at an estimated total vertical depth of 4085 feet, and then to continue to build angle to 90 degrees and thence drilling horizontally in a lateral distance not in excess of 4689 feet and no closer than 330 feet to the outer boundaries of the 320-acre spacing and proration unit. See Exhibits "A," "B," and "C."

(5) Applicant proposes that Decretory Paragraphs
(1) and (2) of Division Order R-9702 be deleted and new
Decretory Paragraphs (1) and (2) be adopted as follows"

"(1) The applicant, Meridian Oil Inc. is hereby authorized to initiate a high angle/horizontal directional drilling pilot project in the W/2 of Section 20, T30N, R15W, NMPM, Undesignated Horseshoe-Gallup Oil Pool, San Juan County, New Mexico, by drilling its Black Diamond "20" Well No.1 from an unorthodox surface location 120 feet from the North and West lines (Unit D) of Section 20, in the following unconventional manner:

Drill vertically to a depth of approximately 4250 feet and then come up hole to a point at approximately 3579 feet and kick off the well in an southeasterly direction (approximately azimuth of 155 degrees) and commence to build an angle of 12 degrees per 100 feet to approximately 80 degrees and penetrate the top of the Waterflow" zone of the Niobrara member of Horseshoe Gallup Oil Pool at an estimated total vertical depth of 4085 feet, and then to continue to build angle to 90 degrees and thence drilling horizontally in a lateral

distance not in excess of 4689 feet and no closer than 330 feet to the outer boundary of the designated project area.

**PROVIDED HOWEVER THAT**, no portion of the horizontal portion of the wellbore shall be located closer than 330 feet from the outer boundary of the project area."

(2) The applicant shall dedicate the W/2 of Section 20 to the above described well forming a nonstandard 320 acre oil spacing and proration unit which is also hereby approved."

(6) The Waterflow interval of the Gallup is believed to be the potential productive zone at this location in the Horseshoe Gallup Oil Pool. This interval produces through intergranular permeability.

(7) Past experience in said pool has shown that unless a conventionally drilled (vertical) well intersects natural fractures, the chance of obtaining commercial production is severely curtailed.

(8) By amending its surface location, applicant is attempting to increase the probability of encountering several of these fractures, which may ultimately result in the recovery of a greater amount of gas and oil, thereby preventing waste.

(9) In as much as the exact distance and direction of the lateral portion of the wellbore is not known at this time, the Applicant seeks approval to be allowed to drill and produce said lateral portion anywhere within an area designated a target window as follows: commencing at a distance not closer than 330 feet from any of the side boundaries of the proposed spacing unit so that within the drilling window no portion of the wellbore open for production shall be closer than 330 feet to the outer boundary of the spacing unit.

(10) As required, notice is provided to those offsetting operators as listed on Exhibit "D."

(11) The granting of this Application will be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Applicant requests that this matter be set for hearing on April 22, 1993 before a duly appointed Examiner of the Oil Conservation Division and, after notice and hearing as required by law, the Division enter its Order granting this application.





