

Application of Yates Petroleum Corporation for an unorthodox gas well location, Eddy County, New Mexico. Applicant seeks authorization to drill to the Morrow formation, Cemetary Morrow Gas Pool, its Conoco AGK Federal Well No. 15 at a location 660 feet from the South line and 1980 feet from the East line (Unit O) of Section 26, Township 20 South, Range 24 East, N.M.P.M., Eddy County, New Mexico. The E/2 of said Section 26 is to be dedicated to said well forming a standard 320-acre gas spacing and proration unit.
