



COMES NOW DEVON ENERGY CORPORATION, by its undersigned attorneys,  
hereby makes application to the Oil Conservation Division for an Order promulgating  
Special Pool Rules and Regulations for the Soapberry Draw-Delaware Pool and in support  
thereof states:

1. Devon Energy Corporation is the operator of the Cactus State Well No. 1 located 960 feet from the North line and 1860 feet from the West line of Section 16, Township 21 South, Range 26 East, N.M.P.M., in the Soapberry Draw-Delaware Pool which was established on November 5, 1991 by Order No. R-9476-A and includes the SE/4 of Section 8 of Township 21 South, Range 26 East, N.M.P.M., Eddy County, New Mexico.
2. The wells in the Soapberry Draw-Delaware Pool are operated under statewide rules including a 2000 to 1 Gas/Oil Ratio.
3. Producing this well at the currently authorized Gas/Oil Ratio will result in oil ultimately being left in the ground.


4. Devon Energy Corporation seeks establishment of a special Gas/Oil Ratio for the pool of 6,000 cubic feet of gas per barrel of oil produced.

5. Approval of this application will result in the production of hydrocarbons which otherwise will not be produced, will protect correlative rights and is in the best interest of conservation.

WHEREFORE, Devon Energy Corporation requests that this application be set for hearing before a duly appointed Examiner of the Oil Conservation Division on June 17, 1993 and that, after notice and hearing as required by law and the rules of the Division, the Division enter its Order promulgating Special Pool Rules and Regulations for the Soapberry Draw-Delaware Pool including provisions for a special Gas/Oil Ratio of 6,000 cubic feet of gas per barrel of oil produced.

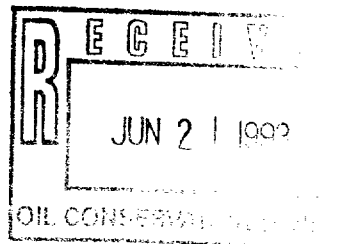

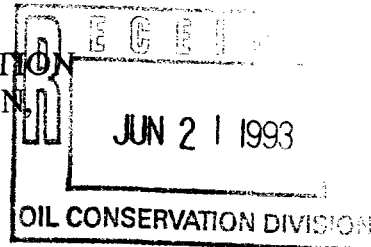



Devon Energy Corporation is the operator of the Cactus State Well No. 1 located 960 feet from the North line and 1860 feet from the West line of Section 16, Township 21 South, Range 26 East, N.M.P.M., which is an oil well immediately offsetting to the south in the East-Catclaw Draw-Delaware Pool which was established on February 1, 1991 by Order No. R-9418 and has been extended from time to time to include Section 9, Township 21 South, Range 26 East, N.M.P.M., Eddy County, New Mexico.
2. The wells in the East Catclaw Draw-Delaware Pool are operated under statewide rules including a 2000 to 1 Gas/Oil Ratio.
3. Producing this well at the currently authorized Gas/Oil Ratio will result in oil ultimately being left in the ground.
4. Devon Energy Corporation seeks establishment of a special Gas/Oil Ratio for the pool of 6,000 cubic feet of gas per barrel of oil produced.

5. Approval of this amended application will result in the production of hydrocarbons which otherwise will not be produced, will protect correlative rights and is in the best interest of conservation.
