In reviewing the County Records for this Federal Lease it is apparent that there are numerous holes in the title chain that hopefully could be cleared up by a complete review of the Federal Lease file at the BLM and further research of the Grantor/Grantee Index of the San Juan County Clerk. Problems of particular note are as follows:

- 1) There is no Assignment of this Federal Lease NM 020496 from the original Lessee El Paso Natural Gas Company to Frank Yockey.
- 2) Frank Yockey Assigned all his interest in NM 020496 back to El Paso Natural Gas Company by Assignment dated 1-21-60, then Frank Yockey assigned all his interest in the same lease to Bradley Keyes by Assignment dated 6-17-68. An Operating Agreement for the S $\frac{1}{4}$ of Section 20 dated 6-1-69 signed by EPNG as Non-Operator acknowledges the interest of Bradley Keys and the other owners for the S $\frac{1}{4}$ of Section 20 listed above.

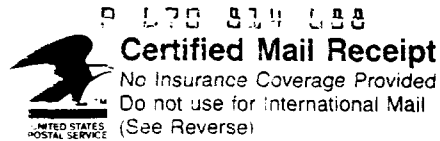

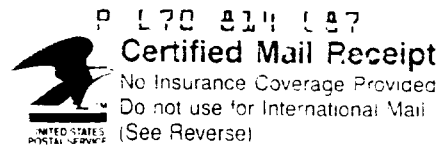
