This letter is to advise you that Yates Petroleum Corporation has filed the enclosed application with the New Mexico Oil Conservation Division seeking approval to drill its Beauregard ANP State Com No. 1 Well in the Abo, Cisco, Canyon, Strawn, Atoka and Morrow formations, Illinois Camp-Morrow Gas Pool.
