ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on August 26, 1993, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this _____ day of October, 1993 the Division Director, having considered the testimony, the record and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) The applicant, Kinlaw Oil Corporation, seeks authority to initiate a short radius high angle/horizontal directional drilling pilot project in the South Denton-Devonian Pool underlying the NE/4 SE/4 of Section 35 and the NW/4 SW/4 of Section 36, both in Township 15 South, Range 37 East, NMPM, Lea County, New Mexico, thereby creating a non-standard 80-acre oil spacing and proration unit for said pool.
- (3) The applicant perposes to re-enter the Bristol Resources Corporation New Mexico "M" Well No. 1 located at a standard surface location 1980 feet from the South line and 660 feet from the West line (Unit L) of said Section 36 in the following unconventional manner:

Mill the 7-inch casing from approximately

13,042 feet to 13, 092 feet, set a cement plug and kick off from the vertical at a depth of approximately 13,062 feet and drill in a southwesterly direction building angle to approximately 96 degrees, continue drilling horizontally a distance of 500 to 700 feet in the Devonian formation.

- (4) The applicant further seeks the adoption of special operating provisions and rules within said pilot project area including the designation of a target window within said pilot project area such that the horizontal or producing portion of the wellbore shall be no closer than 330 feet to the outer boundary of the proration unit and for a special project oil allowable to be assigned thereto in accordance with Division General Rule 104.H based upon the unit size of 80% acres.
- (5) Subsequent to the hearing the applicant requested that this matter be <u>dismissed</u>.

IT IS THEREFORE ORDERED THAT:

Division Case No. 10806 is hereby dismissed.

This cause came on for hearing at 8:15 a.m. on August 26, 1993, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this _____ day of September, 1993, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) The applicant, Kinlaw Oil Corporation ("Kinlaw") seeks authority to initiate a horizontal directional drilling pilot project located on a non-standard oil proration unit comprised of the NE/4 SE/4 of Section 35 and the NW/4 SW/4 of Section 36, Township 15 South, Range 37 East, NMPM, South Denton-Devonian Pool, Lea County, New Mexico. Applicant also seeks approval of the unorthodox well location for this well and the adoption of provisions within said project area including special well location requirements and allowable considerations.

- (3) Kinlaw proposes to reenter its Magnolia Petroleum New Mexico "M" Well No. 1 located at a standard surface location 1980 feet from the South line and 660 feet from the West line of Section 36, Township 15 South, Range 37 East, NMPM, Lea County, New Mexico.
- (4) The proposed horizontal well will be located within the boundaries of the South Denton-Devonian Pool and, as such, would be subject to general rules and regulations for oil pools which require 40-acre spacing and proration units with wells to be located no closer than 330 feet from the outer boundary of the unit.
 - (5) Kinlaw proposes to complete said well in the following manner:

Directionally drill said well by kicking off from the vertical in the Devonian formation at a depth of approximately 13,042 feet, drill a short-radius curve in such a manner as to penetrate the Devonian formation horizontally, utilize existing and proven technology to drill horizontally within the Devonian formation in a southwesterly direction a distance of 500 feet to 700 feet, and produce the Devonian formation throughout the entire horizontal interval.

- (6) As a result of the proposed completion, the producing interval in the well may include an area underlying both the NE/4 SE/4 of said Section 35 and the NW/4 SW/4 of said Section 36.
- (7) The applicant presented evidence that demonstrates the wellbore will be located a minimum distance of 330 feet from the outer boundary of the acreage dedicated to it and, as such, will not encroach upon offsetting proration units, thereby protecting correlative rights.
- (8) Testimony by the applicant further indicated that this type of well completion in the South Denton-Devonian Pool should result in the recovery of oil that will otherwise not be recovered, thereby preventing waste.
- (9) All offset acreage is operated by Kinlaw Oil Corporation, and, therefore, there are no offset operators affected by the proposed horizontal directional drilling project.

(10) In the interest of conservation, prevention of waste, and protection of correlative rights, the application of Kinlaw Oil Corporation should be granted approving a horizontal directional drilling project on a non-standard oil proration unit comprised of the NE/4 SE/4 of Section 35 and the NW/4 SW/4 of Section 36, Township 15 South, Range 37 East, NMPM, provided, however, that (a) the bottomhole location of the well should not be located closer than 330 feet to the outer boundary of the project area and (b) the applicant should be required to conduct a directional survey on the well during the drilling of or after the completion of drilling operations on the well, and submit to the Santa Fe office of the Division a copy of said directional survey. An allowable of 910 barrels of oil per day should be established for this 80-acre project area, which is equal to the allowable assigned to a standard 40-acre proration unit in the pool times two.

IT IS THEREFORE ORDERED THAT:

- (1) The application of Kinlaw Oil Corporation for a horizontal directional drilling project consisting of a non-standard oil proration unit in the NE/4 SE/4 of Section 35 and the NW/4 SW/4 of Section 36, Township 15 South, Range 37 East, NMPM, South Denton-Devonian Pool, Lea County, New Mexico, is hereby approved.
- (2) The applicant is further authorized to reenter its Magnolia Petroleum New Mexico "M" Well No. 1 at a standard surface location 1980 feet from the South line and 660 feet from the West line of Section 36, in the following manner:

Directionally drill said well by kicking off from the vertical in the Devonian formation at a depth of approximately 13,042 feet, drill a short-radius curve in such a manner as to penetrate the Devonian formation horizontally, utilize existing and proven technology to drill horizontally within the Devonian formation in a southwesterly direction a distance of 500 feet to 700 feet, and produce the Devonian formation throughout the entire horizontal interval.

- (3) The bottomhole location of the proposed well shall not be located closer than 330 feet to the outer boundary of the project area.
- (4) The applicant shall conduct a directional survey on the proposed well during the drilling or after the completion of drilling operations on the well and shall submit to the Santa Fe office of the Division a copy of said directional survey.
- (5) The 80-acre pilot project area shall be assigned an allowable of 910 barrels of oil per day.
