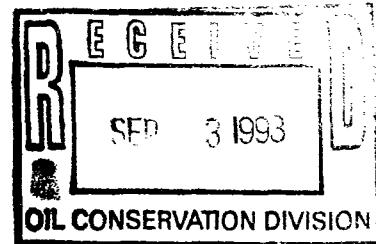



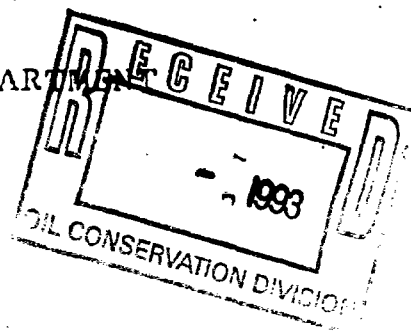

STATEMENT OF CASE

APPLICANT

Reenter each of the listed wellbores mill a 60'+ - section in the existing 5.5" casing. Set a cement plug drilled to a predetermined kick-off point. Kick-off from vertical, build angle with a 60' to 80'+ - short radius arc to approximately 90' into the San Andres Pay Zone. Continue to drill horizontally 800' to 1400' into the Pay Zone maintaining a distance of 100' from any LEASE LINE BOUNDARIES. Reason for this procedure is to attempt to economically recover Oil & Gas reserves from these leases that have not been recovered from the conventional vertical wellbores.



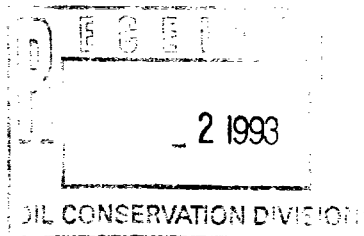


