## APPLICATION

Mewbourne Oil Company hereby applies for the promulgation of Special Rules and Regulations for the Walters Lake-Bone Spring Pool, including a gas:oil ratio of 5,000 cubic feet of gas per barrel of oil produced, and in support thereof states:

1. The Walters Lake-Bone Spring Pool was created by Division Order No. R-8827, dated January 1, 1989, and currently includes the following described acreage:

Township 18 South, Range 30 East, N.M.P.M.

Section 2:  $S_{\frac{1}{2}}^{\frac{1}{2}}$ Section 3:  $S_{\frac{1}{2}}^{\frac{1}{2}}$ , NW<sup>1</sup><sub>4</sub>

The depth bracket allowable for said Pool is 187 barrels of oil per day.

2. Applicant operates or owns interests in wells in the Pool, which is produced under statewide rules which limit production to 187 barrels of oil per day at a gas:oil ratio of 2,000 cubic feet of gas per barrel of oil produced.

3. Applicant seeks the promulgation of Special Rules and Regulations for the Pool to increase the limiting gas:oil ratio to 5,000 cubic feet of gas per barrel of oil produced.

4. Approval of this application will protect the correlative rights of interest owners in the Pool by affording each interest JGB5\93K47.d

owner the opportunity to produce its just and equitable share of gas and oil from the Pool, will prevent the waste of hydrocarbons, and is otherwise in the best interests of conservation.

WHEREFORE, Applicant requests that this application be set for hearing on December 2, 1993, and after notice and hearing as required by law, the Division enter its Order approving this application.


