STATEMENT OF CASE

APPLICANT

In Case No. 10986, Santa Fe seeks to contract the Indian Basin-Upper Pennsylvanian Gas Pool ("the Gas Pool") by deleting therefrom Sections 4-8 (T22S, R24E) and Section 1 (T22S-R23E), and adding said acreage to the Indian Basin-Upper Pennsylvanian Associated Pool ("the Associated Pool"). The above acreage was once productive in the Gas Pool. However, recent completions on

said acreage have been in the interval productive in the Associated Pool, and are oil wells. As a result, Santa Fe believes that additional wells in the area should be governed by the rules for the Associated Pool. The transfer of acreage to the Associated Pool will simplify approvals for additional wells planned in the area by Santa Fe and other operators.

In Case Nos. 10977, 10987, 10988 and 10989, Santa Fe seeks approval to drill four wells to test the interval producing in the Associated Pool, which is spaced on 320 acres. However, the wells are within the boundaries of the Gas Pool, and thus require approval for non-standard 320 acre (more or less) units. In addition, all locations are non-standard under the special rules for the Gas Pool, and Santa Fe requests approval of said locations, which are necessitated by both geological and topographical reasons.

**NOTE:** If the application in Case No. 10986 is approved, the locations and proration units in Case Nos. 10977 and 10987 are standard, and those two cases could then be dismissed. However, the locations and proration units in Case Nos. 10988 and 10989 are non-standard under the pool rules for the Associated Pool.


