


MEWBOURNE OIL COMPANY, through its undersigned attorneys, hereby makes application to the Oil Conservation Division for an order approving an unorthodox well location in the Morrow formation, and in support of this application states:

1. Applicant is the operator of the N/2 of Section 26, Township 20 South, Range 25 East, N.M.P.M., Eddy County, New Mexico and proposes to drill its Babbling Springs "26" Federal Well No. 1 in the Morrow formation, Wildcat Morrow Gas Pool, at an unorthodox location 1650 feet from the North and West lines (Unit F) of said Section 20.
2. Applicant seeks an exception to Rule 104 of the General Rules and Regulations of the Division to permit the drilling of this well at the above-described location.
3. The above-described 320-acre standard proration unit should be dedicated to the well.
4. Approval of this application will afford applicant the opportunity to produce its just and equitable share of the oil and gas from the Morrow formation and will otherwise be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Mewbourne Oil Company requests that this application be set for hearing before an Examiner of the Oil Conservation Division on June 9, 1994, that notice be given as required by law and the rules of the Division, and that the Division enter its Order granting this application and providing such other relief as is proper.


