



This letter is to advise you that Armstrong Energy Corporation has filed the enclosed application with the New Mexico Oil Conservation Division seeking approval to drill its Mobil Lea State Well No. 6, at a location 2,590 feet from the North line and 1,980 feet from the West line of Section 2, Township 20 South, Range 34 East, N.M.P.M., Lea County, New Mexico in the Delaware formation, Northeast Lea-Devonian Pool. The SE/4 NW/4 of Section 2 will be dedicated to this well.

This application has been set for hearing before a Division Examiner on July 7, 1994. You are not required to attend this hearing, but as an owner of an interest that may be affected by the unorthodox well location, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
