

APPLICATION

TEXACO EXPLORATION AND PRODUCTION INC. ("Texaco"), through its undersigned attorneys, hereby makes application to the Oil Conservation Division for the creation of a new pool for the production of oil from the Drinkard and Abo formations, and the promulgation of Special Pool Rules and Regulations for the pool including a special limiting gas-oil ratio of 10,000 cubic feet of gas per barrel of oil produced and in support hereof states:

1. Texaco operates its F.B. Davis Well No. 1 in the NW/4 NE/4 of Section 8 which is dually completed in the Drinkard formation and Abo formation and the G.W. Sims Well No. 1 in the NW/4 NE/4 of Section 9, Township 23 South, Range 37 East, NMPM, Lea County, New Mexico which is completed in the Drinkard formation. Although the boundaries of the Teague-Drinkard Pool have not been extended to include this acreage, both the F.B. Davis Well No. 1 and the G.W. Sims Well No. 1 are classified as Teague-Drinkard Pool producers. The Abo production from the F.B. Davis No. 1 is classified as undesignated Abo production.

2. Data from these wells shows that the Drinkard and Abo formations can be produced together without damage to either of the formations and they should be produced as one pool.

3. The Drinkard and Abo formations under this acreage constitute a separate source of supply for which no pool has been created by the Division.

4. The proposed horizontal limits of this pool should include the following acreage:

Township 23 South, Range 37 East, NMPM

Section 8: NE/4 NE/4

Section 9: N/2 NW/4, NW/4 NE/4


5. Texaco also seeks the promulgation of Special Rules and Regulations for this Pool including a special gas-oil ratio limitation of 10,000 cubic feet of gas per barrel of oil produced.

6. Approval of this application will result in the efficient and effective development of the Drinkard and Abo formations in the area affected by this application and will otherwise be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Texaco Exploration and Production Inc. requests that this application be set for hearing before a duly appointed Examiner of the Oil Conservation Division on July 7, 1994 and that, after notice and hearing as required by law, the Division enter its order approving this application.
