



Dear Mr. LeMay:

On January 3, 1995, the New Mexico Oil Conservation Division granted an extension of time until April 15, 1995 to commence drilling wells pursuant to Order Nos. R-10167, R-10169, and R-10170. Currently, AnSon is attempting to resolve surface damage disputes with a surface owner, but has not been able to come to an agreement at this time. In addition, AnSon only recently received seismic data on the subject area, and would like additional time to review the data. For these reasons AnSon will be unable to commence drilling by April 15, 1995.

Accordingly, AnSon requests that it be granted an extension until June 15, 1995 to commence drilling its wells pursuant to Order Nos. R-10167, R-10169, and R-10170.



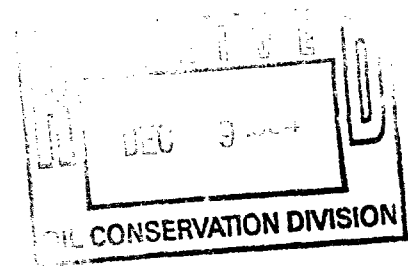


On August 9, 1994, the New Mexico Oil Conservation Division entered Orders R-10169, R-10167, and R-10170 granting the applications of AnSon Gas Corporation for compulsory pooling in each of the above-referenced cases. On October 18, 1994, the Commission granted an extension of time until January 15, 1995, to commence drilling wells in the pooled units. AnSon still intends to complete its wells as quickly as possible but has experienced substantial completion difficulties in its Anderson 33 #1 well and is unable to move as quickly in the development of the unit as it had hoped. In addition, AnSon is currently evaluating 3-D seismic data which recently has been shot and processed covering the relevant area of Section 33, and anticipates drilling once the data is evaluated.




Dear Mr. LeMay:

On August 9, 1994 the New Mexico Oil Conservation Division entered Orders R-10169, R-10167 and R-10170 granting the applications of AnSon Gas Corporation for compulsory pooling in each of the above-referenced cases. 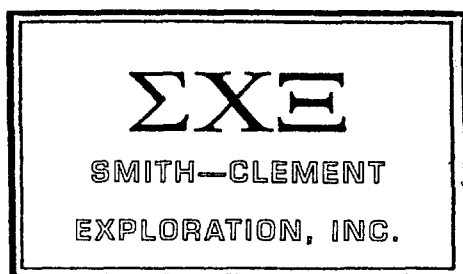
