State Com R Well No. 14, located 940 feet FSL and 990 feet FWL (Unit M) Sec 36, T30N, R9W, with the S/2 dedicated to the Blanco-Mesaverde Pool and the SW/4 to the Blanco-Pictured Cliffs Pool. Said well is located approximately 6.5 miles northeast from Blanco, New Mexico;

State Com Q Well 13A, located 1500 feet FSL and 1450 feet FEL, (Unit J) Sec 36, T29N, R8W, with the E/2 dedicated to the Blanco-Mesaverde Pool and the SE/4 to the Blanco-Pictured Cliffs Pool. Said well is located approximately 1.5 miles northwest from Navajo City, New Mexico;

APPLICATION

Comes now CONOCO INC., ("Conoco") by and through its attorneys, Kellahin and Kellahin, and applies to the New Mexico Oil Conservation Division for approval to downhole commingle Blanco-Pictured Cliffs Gas Pool production or South Blanco-Pictured Cliffs Gas Pool production with Blanco-Mesaverde Gas Pool production within the wellbore of the following four wells:

State Com R Well No. 14, located 940 feet FSL and 990 feet FWL (Unit M) Sec 36, T30N, R9W, with the S/2 dedicated to the Blanco-Mesaverde Pool and the SW/4 to the Blanco-Pictured Cliffs Pool.

State Com Q Well 13A, located 1500 feet FSL and 1450 feet FEL, (Unit J) Sec 36, T29N, R8W, with the E/2 dedicated to the Blanco-Mesaverde Pool and the SE/4 to the Blanco-Pictured Cliffs Pool.

State Com G Well No. 2A, located 1650 feet FSL and 1650 feet FEL (Unit J) Sec. 32, T29N, R8W, with the S/2 dedicated to the Blanco-Mesaverde Pool and the SE/4 to the Blanco-Pictured Cliffs Pool.

State Com Well No. 47, located 1760 feet FSL and 835 feet FWL (Unit L) Sec 2, T27N, R8W, with the S/2 dedicated to the Blanco-Mesaverde Pool and the SW/4 to the South Blanco-Pictured Cliffs Pool.

In support of its application, Conoco states:

(1) Conoco is the operator for each of the four wells which are existing Pictured Cliffs and Mesaverde dually completed producing wells, shown on the following exhibits:

State Com R Well No. 14:	Mesaverde Pictured Cliffs	See Exhibit "A" See Exhibit "B"
State Com Q Well No 13A:	Mesaverde Pictured Cliffs	See Exhibit "C" See Exhibit "D"
State Com G Well No. 2A:	Mesaverde Pictured Cliffs	See Exhibit "E" See Exhibit "F"
State Com Well No. 47:	Mesaverde Pictured Cliffs	See Exhibit "G" See Exhibit "H"

(2) Each well is to be reconfigured so that production from the Blanco-Mesaverde Pool and from either the South Blanco-Pictured Cliffs or the Blanco-Pictured Cliffs Gas Pool can be downhole commingled in the wellbore.

(3) The ownership is not common between these two spacing units.

(4) In accordance with Division Rule 303-C-1.(b), the Applicant states and will demonstrate at hearing:

1. That each well is currently a dual completion in the Pictured Cliffs and in the Mesaverde formations, is marginal and production cannot be economically continued unless it is done so by downhole commingling that production.

2. That there will be no crossflow between the two zones commingled.

3. That the value of the commingled production will not be less than the sum of the values of the individual production.

4. It is expected that the bottom hole pressure of the lower pressure zone is not less than 50 percent of the bottom hole pressure of the higher pressure zone adjusted to a common datum.

(5) In order to salvage the remaining Pictured Cliffs production and Mesaverde production from this spacing unit, Conoco seeks approval to produce each of these wells as downhole commingled wells.

(6) Conoco will submit at the hearing, its proposed formula for the allocation of production to each of the commingled zones and a description of the factors or data used in determining such formula.


(7) That in order to allocate the commingled production to each of the commingled zones in these wells, Conoco requests a provision in the order delegating to the Supervisor of the Aztec District Office of the Division the authority to determine an allocation formula for each of the production zones.

(8) Applicant requests that this matter be docketed for hearing on the Division's Examiner docket now scheduled for July 21, 1994.


(9) Notice of this application has been sent to all owners of production within each of the spacing units who may be affected by downhole commingling as identified on Exhibit "I" attached.

UNIT






--- MESAVERDE PRORATION UNIT



MESAVERDE WELLS ONLY



--- PICTURED CLIFF PRORATION UNIT



PRORATION UNIT





