APPLICATION OF PARKER AND PARSLEY PETROLEUM COMPANY FOR DOWNHOLE COM-MINGLING, EDDY COUNTY, NEW MEXICO

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on April 12, 1989, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this ____ day of April, 1989 the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

(1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

- (2) The applicant, Parker and Parsley Petroleum Company, is the owner and operator of the Pardue Farms "27"

 Btry. 1 Well No. 4, located 660 feet from the South and East lines (Unit P) of Section 27, Township 23 South, Range 28

 East, Eddy County, New Mexico.
- (3) The applicant seeks authority to commingle production from the Undesignated East Loving-Delaware Pool, which was formerly known as the Brushy (Delaware) Canyon, and the South Culebra Bluff-Bone Spring Pool within the wellbore of the above described well.
- (4) From each of the zones the subject well is capable of low marginal production only.
- (5) The proposed commingling may result in the recovery of additional hydrocarbons from each of the subject pools, thereby preventing waste, and will not violate correlative rights.
 - (6) The fluids produced by each pool are compatible.
- (7) The oil produced from each pool is of similar observed gravity.
- (8) The gas produced from each pool is of similar Btu content.
- (9) The ownership, both royalty and working interest, is common in both pools.
- (10) Allocation of the commingled production from the subject well should be as follows:

IT IS THEREFORE ORDERED THAT:

- (1) The applicant, Parker and Parsley Petroleum Company, is hereby authorized to commingle production from the Undesignated East Loving Delaware and South Culebra Bluff Bone Spring Pools within the wellbore of its Pardue Farms "27" Btry. 1 Well No. 4, located 660 feet from the South and East Lines (Unit P) of Section 27, Township 23 South, Range 28 East, Eddy County, New Mexico.
- (2) Production of the commingled zones from the subject well shall be allocated as follows:

| South Culebra Bluff Bone Spring | 3 % | 8% |

(3) Jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
