Dear Mr. Lemay:

The above order, entered November 27, 1989, force pooled the W1 of Section 16, Township 21 South, Range 35 East. The only party force pooled by the order was Chevron U.S.A. Inc. The order provided that the operator (Santa Fe Energy) was to commence the drilling of the well on or before February 15, 1990.

Since the causer was entered, Santa Fe Energy and Chevron have had additional discussions regarding Chevron's voluntary Those negotiations are ongoing at this joinder in the well. As a result, Santa Fe Energy requests that deadline for commencing the well be extended to April 15, 1990.
