The archaeological survey Technical Report No. 1740 was conducted on November 1989. Due to extensive archaeological constraints the well could not be located in an orthodox location. Our addendum to the archaeological survey of the proposed Bannan Federal 8-2 well pad located southeast of Lybrook, Rio Arriba County, New Mexico is enclosed. No cultural manifestations were found. Two previously recorded sites, DCA-89-309 and DCA-89-458, lie adjacent to the project boundaries. They are at least 100 ft from construction activities and should not be affected.

We have recommended clearance for the restaked located of the Bannan Federal 8-2 well pad.

The Bureau of Land Management will review this report and make the final decision on archaeological clearance for your project.

Also enclosed is an invoice for our services. Please contact us if you have any questions concerning the report or invoice.

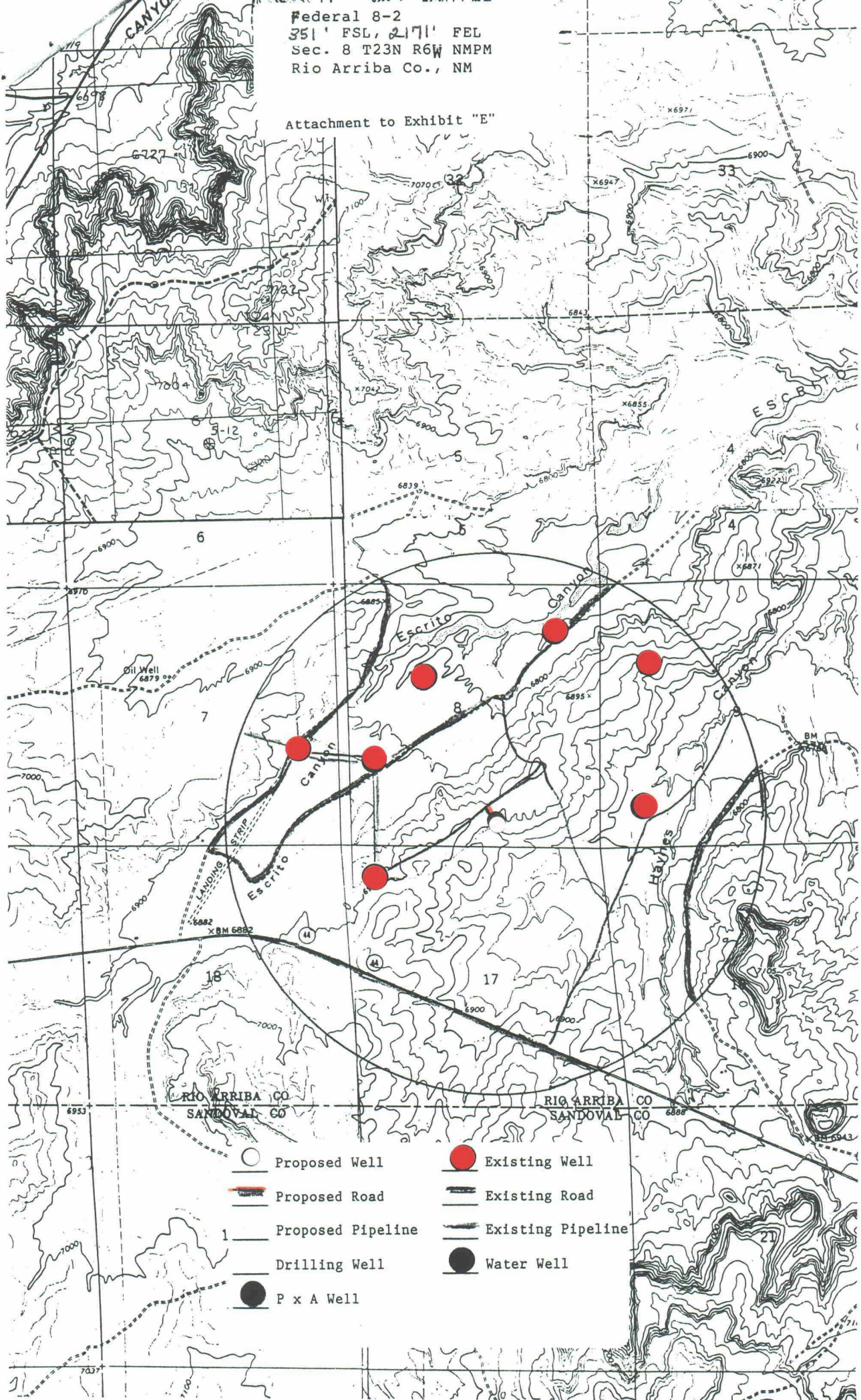


