
HEARING EXAMINER: Thank you, Mr. Carr. It will be so noted.

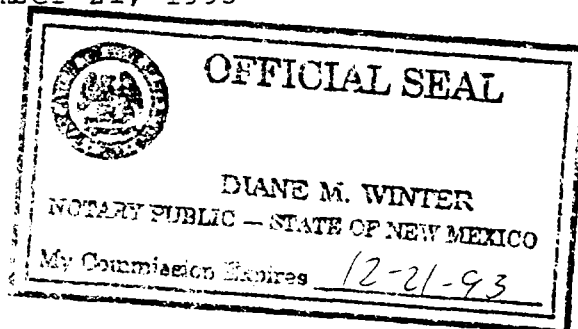
