25 probably be at least two to three hours before they're

1 actually called. Whether they're called before or  
2 after lunch is difficult to predict at this point.

3 If you'll check back about 10:30 to 11:00  
4 to see where we are on the docket at that time, it  
5 will free you up for a couple of hours anyway.
