STATEMENT OF CASE

APPLICANT

TXO Production Corp. proposes to drill another Delaware Sand development well at an unorthodox well location in the NE/4SE/4 of Section 18. Section 18 and the W/2 of Section 17 is all the same federal lease. TXO has unsuccessfully tried to develop a 40-acre stepout well in its Yates Federal No. 6 well in NE/4SE/4 to offset other production on the lease. The unorthodox location is necessary in order to minimize the geologic risk and to recover oil that might not otherwise be recovered thereby preventing waste.

All working interest and royalty ownership is common in the spacing unit and each adjoining spacing unit towards which the well encroaches.
