
Hearing is scheduled before the New Mexico Oil Conservation Division in Santa Fe, New Mexico, on July 11, 1990.

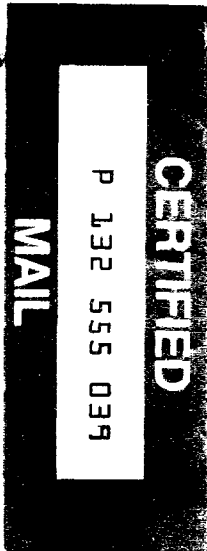

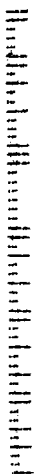
