

APPLICATION

NEARBURG PRODUCING COMPANY, by and through its undersigned attorneys,  
hereby makes application to the Oil Conservation Division for amendment of Division  
Order No. R-8752 and in support of its application states:

1. Applicant is the operator of the N/2 of Section 12, Township 19 South,  
Range 25 East, N.M.P.M., Eddy County, New Mexico.
2. On September 23, 1988 the Division entered Order No. R-8752 in Case 9466  
authorizing Nearburg Producing Company to drill a gas well at an unorthodox gas well  
location 990 feet from the North and East lines (Unit A) of Section 12, Township 19  
South, Range 25 East, N.M.P.M., Undesignated Boyd-Morrow Gas Pool, Eddy County,  
New Mexico.
3. Nearburg Producing Company has drilled and completed its Rose 12-A Well  
No. 1 at the approved unorthodox location but has been unable to complete the well in  
the Undesignated Boyd-Morrow Gas Pool.
4. The well has been completed in the Strawn formation and Nearburg  
Producing Company therefore requests that Order No. R-8752 be amended to authorize


the completion of the Rose 12-A Well No. 1 at a location 990 feet from the North and East lines of said Section 12 in the Pennsylvanian formation.

5. Granting of this application will be in the best interest of conservation, the prevention of waste and the protection of correlative rights.

WHEREFORE, Nearburg Producing Company requests that this application be set for hearing before a duly appointed Examiner of the Oil Conservation Division on August 8, 1990, and that after notice and hearing as required by law, the Division amend Order No. R-8752 to authorize the completion of the Rose 12-A Well No. 1 at a location 990 feet from the North and East lines of Section 12, Township 19 South, Range 25 East, in the Pennsylvanian formation, Eddy County, New Mexico.

Nearburg Producing Company hereby requests administrative approval of an unorthodox well location for the Rose 12A Well No. 1. The proposed location is in the Strawn formation at a point 990 feet from the North and East lines of Section 12, Township 19 South, Range 25 East.

This unorthodox location will result from the recompletion of the Rose 12A Well No. 1 that was originally drilled to the Morrow formation, Undesignated Boyd-Morrow Gas Pool, at an unorthodox location which was approved in this formation by Division Order No. R-8752 (Case 9466).


Nearburg producing Company is the operator of all affected tracts offsetting this spacing unit (N/2 of Section 12) for which the unorthodox location is sought. Therefore, there are no affected offsetting operators to whom notice needs to be provided.

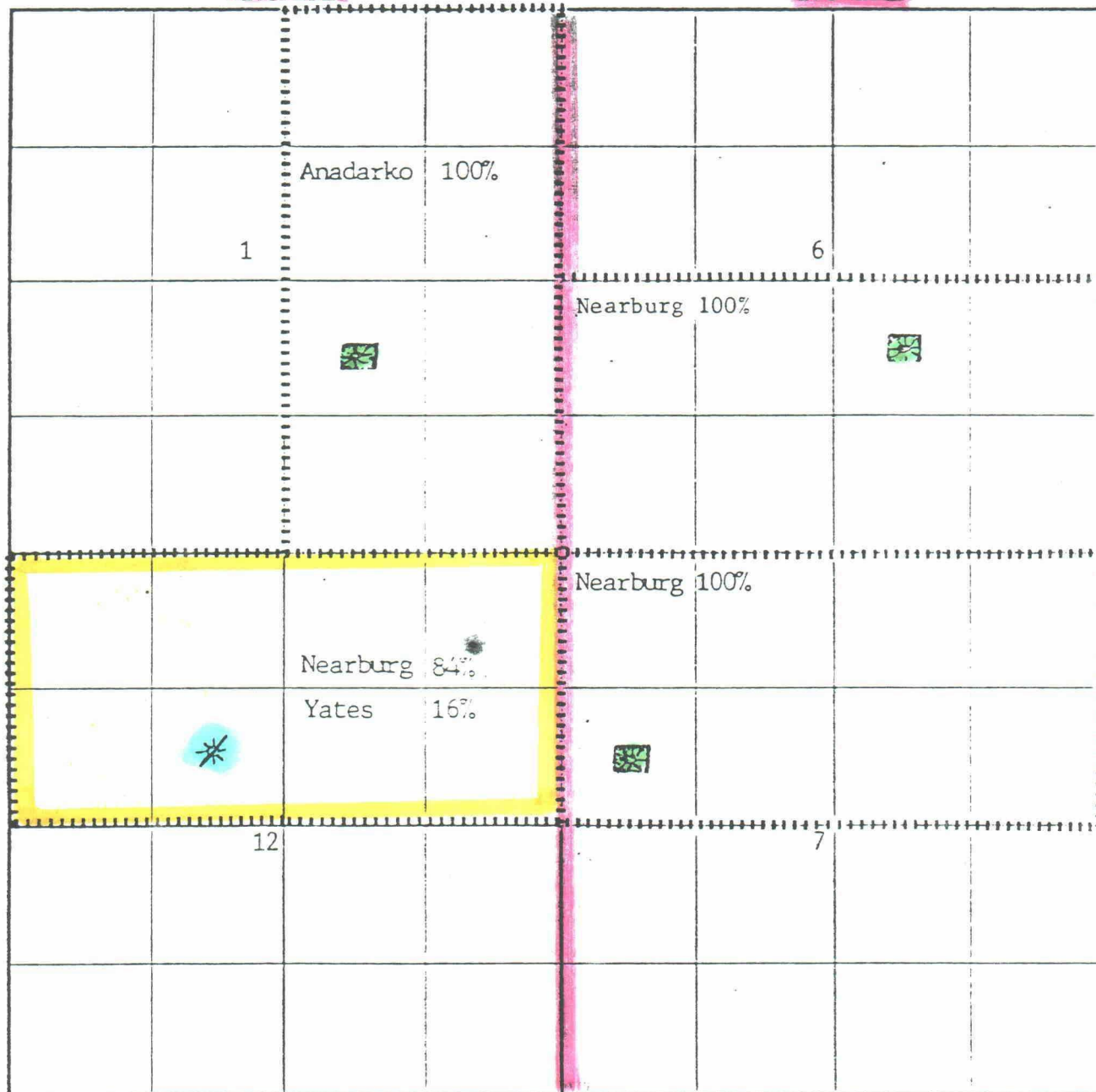
