(7) That the unit operator shall file with the Commission an executed original or executed counterpart of the Rock Queen Unit Agreement within 30 days after the effective date thereof.

(8) That any party owning rights in the unitized substances who does not commit such rights to said unit agreement before the effective date thereof may thereafter become a party thereto by subscribing to such agreement or counterpart thereof, or by ratifying the same. The unit operator shall file with the Commission within 30 days an original of any such counterpart or ratification.

(9) That this order shall become effective upon the approval of said unit agreement by the Director of the United States Geological Survey and the Commissioner of Public Lands for the State of New Mexico and shall terminate <u>ipso facto</u> upon the termination of said unit agreement. The last unit operator shall immediately notify the Commission in writing of such termination.





EXAMINER STOGNER: Going in line, we'll 1 2 call Case No. 10088, which is the application of 3 Circle Ridge Production, Incorporated. 4 I'll call for appearances. 5 MR. BRUCE: Mr. Examiner, I'm Jim Bruce of 6 the Hinkle law Firm in Albuquerque, representing the 7 Applicant, and I have one witness to be sworn. 8 EXAMINER STOGNER: Are there any other 9 appearances? 10 Mr. Bruce, according to your prehearing 11 statement there was an opposing party. Do you know 12 anything about that? 13 MR. BRUCE: No, Mr. Examiner. My client 14 had received an objection by the surface owner, E. P. Caudill, Inc., which apparently was filed with 15 16 the Oil Conservation Division, and that's why I stated 17 that the case was opposed. But I see no opponent here 18 today. 19 EXAMINER STOGNER: Okay. Will the witness 20 please stand to be sworn. You may be seated. Mr. 21 Bruce? 22 MICHAEL L. EXAMINATION 1 2 BY MR. BRUCE: 3 Ο. Would you please state your full name and your city of residence, please? 4 5 Michael L. Pierce, Hobbs, New Mexico. Α. What is your occupation? 6 Q. 7 Α. I'm a consulting geologist. I work for 8 Peak Consulting Services out of Hobbs. 9 Q. Are you consulting on behalf of the 10 Applicant, Circle Ridge, in this case? 11 Α. I am. 12 Have you previously testified before the 0. 13 OCD? 14 Α. No, I have not. 15 Would you briefly outline your educational Q. 16 and work background? 17 Α. I received my Bachelor of Science degree in geology from the University of New Mexico in 1979. 18 19 Since then I worked for Hobbs Pipe & Supply 20 in Hobbs, New Mexico, for five years as an exploration 21 geologist, and then as a consulting geologist for the last four and a half years. 22 23 Have you previously prepared and filed form Q. C-108s regarding injection wells? 24 25 Α. Yes, I have. CUMBRE COURT REPORTING (505) 984-2244

Are you familiar with the matters related 1 Q. to this application? 2 3 Α. I am. MR. BRUCE: Mr. Examiner, is the witness 4 5 qualified? EXAMINER STOGNER: He is. 6 Mr. Pierce, briefly what does Circle Ridge 7 Q. 8 seek in this case? 9 Circle Ridge Production seeks to convert Α. two wells in the Rock Queen Unit that we're currently 10 11 producing to injection wells, to enhance production in 12 the unit. The #3 well is located in Unit C of Section 13 26 and Well #9 is located in Unit I of Section 27, in 14 Township 13 South, Range 31 East, in Chaves County, 15 New Mexico. 16 17 That's in the Rock Queen Unit? Ο. Yes, it is. 18 Α. Would you please refer to the C-108s marked 19 0. as Exhibits 1 and 2, and briefly discuss the injection 20 21 applications? 22 Α. Yes. If we could turn to the land plats to show you the location of these wells and the area of 23 review of the wells, they're both within the confines 24 25 of the unit. If you turn further back we can see the CUMBRE COURT REPORTING (505) 984-2244

casing program and cement and all in the wells for the 1 #3, starting with the #3. 2 The status prior to--it states there it's a 3 producer from an open-hole section 3052 to 3064. The 4 top of cement in that well was 2697 feet with 5 calculated cement, using 50-percent efficiency on that 6 7 one. 8 That was the #3 well? 0. Yes, sir. The #9 well is currently a 9 Α. producer from an open-hole section 3020 feet to 3028. 10 11 The top of cement on this well, using 50-percent 12 efficiency, is 2308 feet. The remaining well diagrams on Exhibits 1 13 0. and 2, are those the wells in the area of review? 14 15 Yes, sir, they are. Α. Were all of these wells, in your opinion, 16 Q. 17 properly cased and cemented? 18 Α. Yes, they are. 19 Are there any problem wells in this area? Q. All of the wells were cemented and . 20 No. Α. 21 cased according to OCD approval, and the P & A'd wells were approved by the OCD, also, the plugging 22 23 procedure ... Did Circle Ridge receive preliminary 24 0. approval to convert these wells? 25 CUMBRE COURT REPORTING (505) 984-2244

Yes. We received approval August 15th, I 1 Α. believe it was, to run an injectivity test and 2 mechanical integrity test on these two wells. 3 Would you refer to Exhibits 3 and 4 and 4 Ο. describe those exhibits? 5 All right. Exhibits 3 and 4 are sundry 6 Α. notices for both wells that were turned in to the OCD 7 8 and to the BLM for the Federal Well #9. These just 9 detail the procedure to convert the wells to injection and estimate the rate and the pressure at which 10 injection will be done. 11 Were mechanical integrity tests conducted? 12 Q. Both the mechanical integrity tests 13 Α. Yes. were completed last week, and I believe a copy of 14 1.5 those have been submitted. Are those Exhibits 5 and 6, submitted to 16 0. 17 the Examiner? 18 Yes, they are. Α. 19 Q. Were there any problems with either of 20 those wells? 21 Α. No. Each well passed. 22 Ο. Would you please describe the proposed initial rate and pressure of injection in these wells? 23 24 Α. The average injection will be approximately 150 barrels a day to a maximum of 300. During the 25 CUMBRE COURT REPORTING (505) 984-2244

injectivity test, the rates, the injection rates, were 1 400 to 450 pounds and at about 175 barrels a day. The 2 maximum pressure that we're looking at is 600 pounds. 3 0. Where does the produced water come from, 4 and is it compatible with the formation water? 5 6 The produced water is from the Queen Α. 7 formation and it is compatible. 8 Is there a proposed stimulation program? Q. 9 Α. No, there's not. Are there any freshwater wells within a 10 Q. 11 mile of the proposed injection wells? 12 Α. No, there are not. 13 Do you have any knowledge of open faults or Q. other hydrologic connection between the injection 14 15 formation and any underground freshwater sources? 16 Α. I do not. 17 Were the surface owners and the offset 0. operators or lease owners notified as required by form 18 C - 108?19 20 Yes, they were. Α. 21 Are the certified receipts marked as Q. 22 Exhibit 7? 23 Α. They are. Is Exhibit 8 a copy of the Affidavit of 24 Q. Publication of the notice of this matter? 25 CUMBRE COURT REPORTING (505) 984-2244

Yes, it is. 1 Α. 2 In your opinion, will the granting of this Q. application be in the interests of conservation, the 3 prevention of waste and the protection of correlative 4 5 rights? 6 Α. It will. 7 Were Exhibits 1 through 8 prepared by you Q. 8 or under your direction? 9 Α. They were. 10 MR. BRUCE: Mr. Examiner, I move the 11 admission of Exhibits 1 through 8. 12 EXAMINER STOGNER: Exhibits 1 through 8 13 will be admitted into evidence. 14 EXAMINATION 15 BY EXAMINER STOGNER: 16 Mr. Pierce, let's start with your schematic Ο. of your proposed injection wells or your test wells. 17 18 Α. Yes, sir. 19 Do you still plan to utilize the tubing 0. 20 which you have shown on your Exhibits 3 and 4 in both 21 of these wells? 22 Α. No, sir. What we've done after approval 23 from the OCD, we ran plastic-lined tubing with 24 Halliburton tension packer and set them both about 25 3000 feet. CUMBRE COURT REPORTING (505) 984-2244

This is what you're planning on doing? 1 0. That's what we've done so that we could do 2 Α. 3 the mechanical integrity test and injectivity test. So how do you plan to put these on 4 0. 5 permanent injection? 6 With that same procedure, plastic-lined Α. 7 tubing, tension plate. 8 Ο. The same 2-7/8-inch plastic-lined tubing 9 with packers? 10 Yes, sir. Α. 11 Do Exhibits 3 and 4 show the packers? Q. 12 No, they do not, sir. They just show the Α. 13 status as producing wells. 14 Q. Okay. Look at Exhibit 3. What is that? 15 Okay. That was the proposal to go ahead Α. 16 and convert these wells to injection. 17 Q. Okay. Now, how is this write-up on portion 18 12, the description of the proposed operations, how 19 does this differ than what you're planning on doing 20 permanently? 21 Α. It does not differ. This is what we're 22 planning to do or what we've done. There was no difference in that. 23 And the **#9** well, that is on federal 24 Ο. 25 acreage? CUMBRE COURT REPORTING (505) 984-2244

1 Α. Yes, sir. 2 Was the BLM notified? 0. Yes, sir. 3 Α. 4 Do you have that notification? I guess I'm 0. 5 missing it. 6 It is the sundry notice, sir. Α. It was 7 submitted as evidence, I think, there. 8 But were they notified of today's hearing? 0. 9 Yes. They knew we were going to hearing. Α. 10 EXAMINER STOGNER: Mr. Bruce, what's your 11 opinion of that notification? Is that adequate, since 12 they are the surface owner pursuant to the C-108? 13 MR. BRUCE: I was not aware they were the 14 surface owner. I thought Mr. Caudill, or E. P. 15 Caudill, Inc., was the surface owner. 16 EXAMINER STOGNER: Also, was the land office notified, other than the C-102 or the C-103 17 sundry noticed? 18 19 MR. BRUCE: If not, Mr. Examiner, we will 20 renotify them. 21 EXAMINER STOGNER: I think we need to 22 renotify them. 23 (BY EXAMINER STOGNER) Okay. Let's look at Ο. Exhibits 5 and 6. These are the results of the 24 25 preliminary test, is that correct? CUMBRE COURT REPORTING (505) 984-2244

Yes, sir. 1 Α. Why don't you be more specific and tell me 2 0. what we're looking at here, in detail. 3 Well, this was the mechanical integrity 4 Α. test performed on the Wells #3 and the #9 and 5 witnessed by OCD personnel, Jack Griffin, out of the 6 Hobbs District. 7 How long did this 30-day test take? 8 Q. 9 We got approval to do a 15-day test, from Α. August 15th to September 1st. 10 And this is it? 11 Q. 12 Well, this is just the mechanical integrity Α. 13 test, sir. 14 Oh, okay. Okay, I'm sorry. Q. Ι misunderstood you then. 15 Yes, sir. 1 unit? Is it shown on that map? 2 Vaquely. Let's see. In 13/31, that Α. Section 23, it includes unit letters B, C and D and 3 That would be the top boundary. 4 not A. 5 0. Okay. 6 And then in Section 22, it includes unit Α. 7 letters A and B, G and H, I, J, K, L, N O and P. 8 Q. Okay. 9 In Section 27, it includes the whole north Α. 10 half save the west half of the northwest quarter, and 11 then the whole southeast quarter of Section 27. In 12 Section 34, the whole northeast guarter, and the south 13 half of the northwest quarter. In Section 35, it 14 includes the north half of the northwest quarter, all 15 of Section 36, all of Section 26, all of Section 25, 16 and all of the south half of Section 24 save the northeast of the southeast. 17 18 Q. Who was the lease operator of the southwest 19 guarter of Section 27? 20 Α. Dakota Resources. 21 Ο. So they took over from City Service, it 22 appears on your map? 23 Yes, sir. Α. 24 Now, who is Mr. Caudill and what is his 0. 25 interest? CUMBRE COURT REPORTING (505) 984-2244

He is the surface lessee out there. 1 Α. Both federal and state? 2 0. 3 Α. I believe the state he is leasing, he may own the surface on section--I'm not sure. He does 4 5 have some--he does own some surface out there outright, but he's the only landowner in the area of 6 review. 7 8 EXAMINER STOGNER: Mr. Bruce, would you check into that? This federal portion may be where I 9 might be misreading it here. They might definitely 10 own the surface but the BLM owns the federal, which 11 12 may look like, to me, an old homestead. 13 But definitely the State Land Office would, 0. 14 I assume, retain their leases and their lands? 15 Yes, sir. Α. 16 MR. BRUCE: We'll check it out, Mr. Examiner. 17 EXAMINER STOGNER: And if you find that the 18 19 BLM does not need to be notified pursuant to the notification procedures on the C-108, if you'll let me 20 21 know, but we'll need get ahold of the Land Office. 22 MR. BRUCE: Okay. 23 ο. (BY EXAMINER STOGNER) And you did a review of all the wells within a half-mile radius, Mr. 24 25 Pierce? CUMBRE COURT REPORTING (505) 984-2244

Yes, sir. All of those are included there. 1 Α. 2 Now, all of these wells within the Ο. 3 half-mile radius have tested the Rock Queen formation, is that correct? 4 5 Α. Yes, sir. 6 Are there any wells deeper than the Rock Q. 7 Oueen? 8 Α. No, sir. What's the nearest water wells? You said 9 Ο. 10 there weren't any within a two-mile radius, if I 11 remember your testimony right. Is this near the 12 Caprock? 13 Α. Yes, sir. It's up above, on top of the Caprock? 14 Q. Part of the field is on the Caprock and 15 Α. part is off of it. 16 17 Are there any water windmills below, off Q. the Caprock? 18 19 Α. I can't answer that. I've never been to 20 that location. 21 Do you know where the nearest water wells Q. 22 are? 23 There's a well in Section 35, and it's not Α. 24 within a mile of the producing wells. 25 But that is the nearest windmill? Q. CUMBRE COURT REPORTING (505) 984-2244

1 Yes, sir. Α. 2 Okay. Are there any plugged and abandoned Ο. wells within a half-mile radius? 3 4 Yes, sir. Those are shown in there. Α. 5 Q. They are properly plugged and abandoned to 6 prevent any migration from the Queen formation? 7 Α. Yes, sir. What will be the source of the water to be 8 0. 9 injected? 10 Α. It would be produced water from the Queen. 11 0. And this will be a unit project only? No 12 outside water or no outside--13 Α. Correct. 14 EXAMINER STOGNER: I do not have any other 15 questions of Mr. Pierce. 16 Are there any other questions of this 17 witness? 18 MR. MORROW: I have one. 19 EXAMINER STOGNER: All right. Go ahead. 20 EXAMINATION 21 BY MR. MORROW: 22 I would ask you, Mr. Pierce, on the two Q. charts it looks like on #3 you had a decline on the 23 24 pressure and an increase on the **#9.** Do you know why that is? 25 CUMBRE COURT REPORTING (505) 984-2244

No, sir, I do not. I was not present when ٦ Α. 2 these tests were run. 3 All right. Thank you. Q. 4 Α. Both these tests were witnessed by Jack Griffin out of the Hobbs office. 5 6 One of them was shown from midnight to 6:00 0. a.m. I don't think that's really right. 7 8 Α. Yeah, I don't think that was probably 9 correct. MR. MORROW: That's all I have. 10 EXAMINER STOGNER: Mr. Bruce, I assume this 11 application will have to be continued--12 13 MR. BRUCE: Yes, Mr. Examiner. EXAMINER STOGNER: -- for proper 14 15 notification?
