Thank you for your letter dated October 25, 1991 notifying us of the difference in the actual surface location of the Debra Geiger Well No. 1 from the location approved by Division Order No. R-9340, dated November 1, 1990.

Under the circumstances and since the actual location is less unorthodox than the authorized location, such change has been duly noted and recorded as being 101' FSL and 173' FEL (Unit P) of Section 32, Township 25 North, Range 11 West, NMPM, San Juan County, New Mexico.

Please take note in the future when requesting an unorthodox surface location as to its "drillability" prior to filing such request.


