Reference is made to your proposal to drill the captioned 790' Fruitland Coal test at 1075' FNL and 1495' FEL of Section 16, Township 29 North, Range 14 West, San Juan County, New Mexico.

This will confirm our telephone conversation this morning during which I advised you that Enron Oil & Gas Company (Enron) does not desire to participate in this test well and indicated Enron's interest in selling all of its right, title and interest in State of New Mexico Lease B-11242-40 covering the NE/4NW/4 of Section 16, Township 29 North, Range 14 West. You subsequently advised that, due to time constraints, Mesa Operating Limited Partnership is not interested in making Enron any kind of an offer to purchase same and plans to proceed with its force pooling action against Enron.

Enron regrets Mesa's decision and would be happy to entertain a purchase proposal should Mesa reconsider its position.
