ARCO OIL & GAS COMPANY ("ARCO"), hereby makes application to the Oil Conservation Division for Amendment of the Special Rules and Regulations for the Empire-Abo Pressure Maintenance Project, Empire-Abo Pool, promulgated by Division Order Nos. R-4549 through R-4549-F, to permit the withdrawal of extraneous gas during winter months and the make-up of amounts withdrawn by injection of additional gas during the succeeding months and in support thereof states:

1. ARCO is the operator of the Empire-Abo Pressure Maintenance Project, Empire-Abo Pool, which was authorized by the Division by Order No. R-4549 and is governed by operating rules contained in Special Rules and Regulations set forth in Division Orders Nos. R-4549-A through R-4549-F.

2. ARCO entered a Gas Injection Agreement with Southern Union Gas Company, now Gas Company of New Mexico ("GCNM") in January 1976 by which GCNM was permitted to inject gas into the Unit until such gas was needed elsewhere by GCNM.

3. By Order No. R-4549-F the withdrawal of specified volumes of extraneous gas was authorized under limited conditions and circumstances.

4. During recent winters the need for natural gas by GCNM from this unit has occurred and, with approval from the Division, withdrawals of volumes in excess of the amounts authorized by Order No. R-4549-F subject to subsequent reinjection of withdrawn amounts plus a fuel volume amount.

5. To meet the needs of GCNM for natural gas during each winter season ARCO seeks amendment of the Special Rules and Regulations for the Empire-Abo Pressure Maintenance Project to authorize:

- a. Permit GCNM, during each of the winter seasons (November 1 to March 31) of 1990-1996, to withdraw up to 300,000 MCF, which volume must be fully replaced during the next succeeding summer season (April 1 - October 31) at a rate not to exceed 2,300 MCFD.
- b. Permit the withdrawal of up to 800,000 MCF during each of the winter seasons of 1996-1998 which volume must be fully replaced during the next succeeding summer season at a rate not to exceed 5,500 MCFD.
- c. Provide that GCNM will, each summer season, in addition to complete replacement of the

volumes withdrawn during the immediately preceding winter season, inject an additional volume of gas equal to 12% of the volume withdrawn and replaced to compensate the Empire-Abo Unit for any fuel used, shrinkage, metering errors, etc. which additional volume will become the property of the Empire-Abo Unit working interest owners.

- d. Provide that until any withdrawn gas is replaced along with the additional 12% volume that no further gas may be withdrawn.
- e. Provide that the provisions of the original Gas Injection Agreement regarding withdrawals will be initiated as of the earliest of (i) the date the Pressure Maintenance Project ceases, or (ii) November 1, 1998.



- b. Permit the withdrawal of up to 800,000 MCF during each of the winter seasons of 1996-1998 which volume must be fully replaced during the next succeeding summer season at a rate not to exceed 5,500 MCFD.
- c. Provide that GCNM will, each summer season, in addition to complete replacement of the

volumes withdrawn during the immediately preceding winter season, inject an additional volume of gas equal to 12% of the volume withdrawn and replaced to compensate the Empire-Abo Unit for any fuel used, shrinkage, metering errors, etc. which additional volume will become the property of the Empire-Abo Unit working interest owners.

- d. Provide that until any withdrawn gas is replaced along with the additional 12% volume that no further gas may be withdrawn.
- e. Provide that the provisions of the original Gas Injection Agreement regarding withdrawals will be initiated as of the earliest of (i) the date the Pressure Maintenance Project ceases, or (ii) November 1, 1998.




