ORDER OF THE DIVISION

This cause came on for hearing at 8:15 A.M. October 31, 1990, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this _____ day of November, 1990, the Division Director having considered the testimony, the record, the recommendations of the Examiner, and being fully advised in the premises:

FINDS:

(1) That due public notice having been given as required by law, the Division has jurisdiction of the cause and subject matter thereof.

(2) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Mississippian formation. Said pool to bear the designation of Big Dog-Mississippina Gas Pool. Said Big Dog-Mississippian Gas Pool was discovered by the Bridge Oil Company L.P. Julia Culp Com Well No. 2 located in Unit H of Section 34, Township 15 South, Range 35 East, NMPM. It was completed July 11, 1990, in the Mississippian formation. The top of the perforations is at 12,992 feet.

(3) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Atoka formation. Said pool to bear the designation of North Bilbrey-Atoka Gas Pool. Said North Bilbrey-Atoka Gas Pool was discovered by the Texaco Producing Inc. North Bilbrey 7 Federal Well No. 1 located in Unit J of Section 7, Township 21 South, Range 32 East, NMPM. It was completed July 30, 1990, in the Atoka formation. The top of the perforations is at 13,153 feet.

(4) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Delaware formation. Said pool to bear the designation of E-K Delaware Pool. Said E-K Delaware pool was discovered by the Santa Fe Energy Operating Partners L. P. New Mexico Federal Well No. 1 located in Unit H of Section 24, Township 18 South, Range 33 East, NMPM. It was completed August 6, 1990, in the Delaware formation. The top of the perforations is at 5,429 feet.

(5) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Atoka formation. Said pool to bear the designation of Southwest Jabalina-Atoka Gas Pool. Said Southwest Jabalina-Gas Pool was discovered by the Tom Brown Inc. Madera 25 Federal Well No. 1 located in Unit J of Section 25, Township 26 South, Range 34 East, NMPM. It was completed June 11, 1987, in the Atoka formation. The top of the perforations is at 15,356 feet.

(6) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Lower San Andres formation. Said pool to bear the designation of West Lovington-Lower San Andres Pool. Said West Lovington-Lower San Andres Pool was discovered by the Mallon Oil Company Mobil "5" State Well No. 1 located in Unit O of Section 5, Township 17 South, Range 36 East, NMPM. It was completed August 17, 1990, in the Lower San Andres formation. The top of the perforations is at 5,272 feet.

(7) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the San Andres formation. Said pool to bear the designation of Southwest Lovington-San Andres Pool. Said Southwest Lovington-San Andres Pool was discovered by the Me-Tex Supply Company New Mexico BM State Well No. 1 located in Unit O of Section 16, Township 17 South, Range 36 East, NMPM. It was completed March 13, 1988, in the San Andres formation. The top of the perforations is at 5,178 feet.

(8) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Wolfcamp formation. Said pool to bear the designation of Salt Lake-Wolfcamp Pool. Said Salt Lake-Wolfcamp Pool was discovered by the Yates Petroleum Corporation Belco AIA Federal Well No. 1 located in Unit J of Section 14, Township 20 South, Range 32 East, NMPM. It was completed August 28, 1990, in the Wolfcamp formation. The top of the perforations is at 11,272 feet.

(9) That there is need for the abolishment of the East Pitchfork Ranch-Atoka Gas Pool, in Lea County, New Mexico. There is no well within the pool capable of producing from the Atoka formation.

(10) That there is need for the contraction of the vertical limits of the West Lovington-San Andres Pool in Lea County, New Mexico, by virtue of Type Log Cities Service State AU Well No. 1 located in Unit D of Section 10, Township 17 South, Range 36 East, and the redesignation of said pool to the West Lovington-Upper San Andres Pool.
