Dear Mr. O'Hare:

Reference is made to our telephone conversation concerning the subject application on Friday, October 26, 1990, where it is my understanding that the reason for the unorthodox location is strictly for economic purposes, or to allow for a single "pumper" to monitor this well along with other wells in this area; and not for topographic reasons as stated in your application. There appears to be adequate locations available to the north on top of the Encinada Mesa.

Knowing the reason for this application and with the information provided, the Division cannot process this application administratively. Therefore, this matter will be set for hearing before a Division Examiner on the next available docket, which is scheduled for November 28, 1990.

Please provide adequate notice for such applications prior to the hearing as required by Division General Rule 1207.



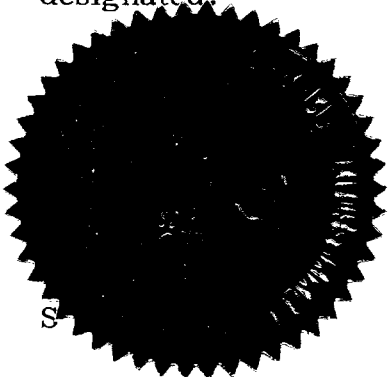

The applicant's request for dismissal should be granted.


