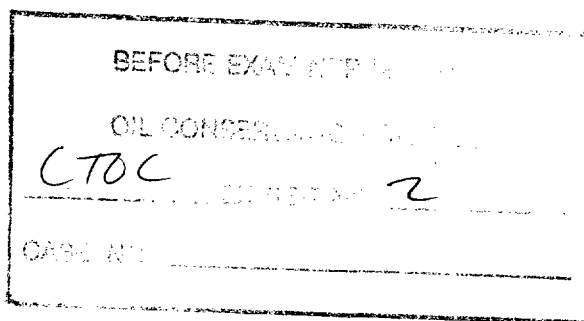

APPLICATION

Cross Timbers Oil Company hereby applies for an order amending Division Order No. R-6849 to increase the gas:oil ratio for the West Nadine-Blinebry Pool ("the Pool"), and to cancel overproduction from one of Applicant's wells in the Pool, and in support thereof states:

1. Applicant is an interest owner in, and an operator in, the Pool.

2. The Pool encompasses the following acreage:

Township 20 South, Range 38 East, N.M.P.M.

Section 4:	SW $\frac{1}{4}$
Section 5:	All
Section 6:	SE $\frac{1}{4}$
Section 7:	N $\frac{1}{2}$
Section 8:	All
Section 9:	W $\frac{1}{2}$
Section 17:	NE $\frac{1}{4}$

3. By Order No. R-6849, the Division adopted a limiting gas:oil ratio ("GOR") for the Pool of 4000 cubic feet of gas for each barrel of oil produced.

4. Applicant requests that the limiting GOR of the Pool be increased to 10,000:1.

5. Applicant operates the McAllister Well No. 4, located in Unit N of Section 5, Township 20 South, Range 38

East, N.M.P.M., which was recently recompleted. Because the recompletion resulted in an increase in oil and gas production, the well inadvertently became overproduced.

6. Applicant requests that the overproduction of the above well be cancelled.

7. The granting of this Application is in the interests of conservation, the prevention of waste, and the protection of correlative rights.

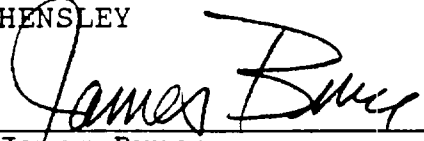
8. Applicant requests that this matter be heard at the January 24, 1991 Examiner hearing.
