

Dear Mr. LeMay:

In the above-referenced case, Kaiser-Francis Oil Company sought the creation of a new pool for the production of gas from the Brushy Canyon Member of the Delaware formation. This request was the result of the discovery of a separate gas reservoir in the Kaiser-Francis AM Federal Well No. 1 located 660 feet from the South line and 1,980 feet from the East line of Section 8, Township 21 South, Range 36 East, N.M.P.M., Eddy County, New Mexico. The proposed new pool included the SE/4 of said Section 8.

By Order No. R-9476, entered on March 26, 1991, the Division found the evidence insufficient at that time to determine whether or not the producing interval was a gas cap in an oil reservoir or a new limited gas reservoir (Finding 11). Accordingly, the Division temporarily denied the application until additional evidence became available on the subject reservoir (Finding 14).

CHI Operating, Inc., an offset operator, appeared in opposition to the application. Order No. R-9476 required that CHI test the subject reservoir in existing or proposed wells in this zone to substantiate the existence of a separate reservoir. This order further gave CHI six months from March 26, 1991 to submit to Kaiser-Francis Oil Company and the Division the data it obtained from this testing.

On September 26, 1991 that information must be provided and at that time, Kaiser-Francis is authorized to seek the reopening of this case.

Kaiser-Francis Oil Company hereby moves that Case No. 10251 be reopened and set for hearing before a Division Examiner on October 17, 1991 to enable it and other affected parties to reexamine this application and determine the most prudent method of producing the reserves in this portion of the Brushy Canyon Member of the Delaware formation.
