




Gentlemen:

This letter is to advise you that Kaiser-Francis Oil Company has filed an application with the New Mexico Oil Conservation Division seeking the creation of a new gas pool as a result of the discovery of hydrocarbons in its AM Federal Well No. 1, located 660 feet from the South line and 1980 feet from the East line of Section 8, Township 21 South, Range 26 East, N.M.P.M., Eddy County, New Mexico, in a perforated interval in the Delaware formation from 4046 feet to 4062 feet. Kaiser-Francis proposes pool boundaries for the new pool which include the SE/4 of said Section 8.

This application has been set for hearing before an Examiner of the Oil Conservation Division on February 21, 1991. You are not required to attend this hearing but as an operator of a well or owner of an unleased mineral interest within the pool, or as an operator of a well within one mile of the proposed pool boundaries, you may appear and present testimony. Failure to appear at that time and become a party of record will preclude you from challenging the matter at a later date.

Parties appearing in cases have been requested by the Division (Memorandum 2-90) to file a Prehearing Statement substantially in the form prescribed by the Division. Prehearing statements should be filed by 4:00 o'clock p.m. on the Friday before a scheduled hearing.
