

1. Applicant is the operator of its Jicarilla "G" Well No. 8-E located 1710 feet from the South and 810 feet from the East line of Section 2, Township 26 North, Range 5 West, N.M.P.M., Rio Arriba County, New Mexico.

2. Applicant proposes to commingle in the wellbore of said well production from the Gallup formation (undesignated Gallup formation and BS Mesa Gallup Pool) and Dakota formation (Basin Dakota Pool).

3. Approval of this application will result in the production of hydrocarbons that would not otherwise be produced, will prevent waste, and will not cause damage to either the Gallup or Dakota formations.


4. Approval of this application will not impair the correlative rights of any offsetting operators.




