APPLICATION

Comes now, CHAMA PETROLEUM COMPANY, by its undersigned attorneys, and hereby makes application for an order approving an unorthodox gas well location, and in support thereof would show the Division:

1. Applicant is the operator of the W/2 of Section 10, Township 20 South, Range 25 East, N.M.P.M., Eddy County, New Mexico.

2. Applicant proposes to dedicate the above-referenced unit to a well to be drilled at an unorthodox location 660 feet from the North and West lines of said Section 10.

3. Applicant seeks an exception to the well location requirements of Oil Conservation Division Rule 104 C II (a) to permit the drilling of a well at the above-mentioned unorthodox location to test the Pennsylvanian formation.

4. Said unorthodox gas well location will avoid the drilling of unnecessary wells, will protect correlative rights and prevent waste.


WHEREFORE, applicant prays that this application be set for hearing on January 16, 1985, before the Division's duly appointed
