Gentlemen:

We are currently in the process of filing an application for permit to drill our proposed Olsen-Blinebry No. 2 Jalmat gas well at a location of 500' FSL and 500' FWL (M) Section 29, T-23-S, R-37-E, Lea County, New Mexico. The newly completed well will be classified as an infill Jalmat gas well and will be simultaneously dedicated to the previously existing 160-acre non-standard Jalmat proration unit consisting of the SW/4 Section 29, T-23-S, R-37-E.

Because of numerous currently existing surface restrictions created by Texaco's Myers Langlie Mattix Unit waterflood which utilizes the same surface acreage as our proposed Olsen-Blinebry No. 2 well, the newly proposed well will be drilled at a non-standard location consisting of 500' FSL and 500' FWL Section 29, T-23-S, R-37-E Lea County, New Mexico instead of the standard 660' location. Therefore, we also respectfully request administrative approval of a non-standard Jalmat (Gas) location for our Olsen-Blinebry No. 2

Furthermore, in compliance with the Natural Gas Policy Act of 1978, a separate application will also be submitted to the Bureau of Land Management to obtain administrative approval for the well as a Section 103 infill well.

Three copies of a plat showing the location of the previously approved 160-acre proration unit plus the location of the proposed new well, along with a plat depicting surface obstructions are enclosed.
