In connection with our proposed B. E. Shipp Estate No. 1 and 2 wells, enclosed please find two (2) AAPL Form 610-1982 Operating Agreements covering the W/2 NE/4 and E/2 NE/4 of Section 4-17S-37E.

As you will note, the commencement date in Article VI.A. Initial Well, has not been inserted and Exhibit "A" is not completed. As soon as we have determined who is participating in our proposed wells, you will be provided with substitute pages.

Pennzoil also wishes to inform you that we have made two (2) separate applications to the Oil Conservation Division of New Mexico for an order pooling all mineral interests underlying the W/2 NE/4 and E/2 NE/4 of Section 4-17S-37E. The hearing is scheduled on the Examiner Docket set for October 9, 1985. We feel this action is necessary due to the fact that we must commence these wells within a certain time period in order to meet our farmout obligations and leasehold expirations.

As soon as we have received a signed AFE and signature page to the operating agreement or you have agreed to lease or farmout, you will be released from both force pooling proceedings.
