A P P L I C A T I O N

Comes now HCW EXPLORATION, INC., by and through its attorneys, Kellahin & Kellahin, and applies to the New Mexico Oil Conservation Division for approval of a 320-acre non-standard proration and spacing unit consisting of the N/2 of Section 31, T23S, R37E, NMPM, Lea County, New Mexico and for approval of an unorthodox gas well location 1650 feet from the North line and 800 feet from the East line of said section, and for simultaneous dedication of acreage to the R. W. Cowden "C" wells Nos. 4 and 9, and in support thereof states:

1. Applicant is operator of the R. W. Cowden "C" #9 well in Unit H, Section 31, T23S, R37E, NMPM, Lea County, New Mexico.

2. Applicant has drilled this Jalmat gas well at a location 1650 feet from the North line and 800 feet from the East line of said Section 31.

3. Applicant desires the simultaneous dedication of this acreage to the subject well and the R. W. Cowden "C" #4 well.

4. That applicant believes that its location in Section 31 will not adversely affect offsetting operators.

5. Applicant believes that the most equitable method for further development of its interests in Section 31 will be the approval of a non-standard 320-acres proration and spacing unit consisting of the N/2 of section 31.

WHEREFORE, applicant requests that this application be set for hearing before the Division's Examiner and that after notice and hearing the application be granted as requested.
