

Gentlemen:

Amoco Production Company respectfully requests that the permanent hardship gas well application for the subject well, which is set for an Examiner's Hearing on June 11, 1986, be withdrawn. Timely granting of an emergency 90 day hardship classification for this well by your office on May 1 has allowed continued recovery of a majority of the load water from the February 1986 fracture stimulation. With the expected recovery of all the load water within the 90 day emergency period, we do not foresee the need for continued hardship status beyond this time frame. Once all the load fluid is recovered, shutting in the well in the event of an upset in the gas market should not jeopardize future reserve recovery.
